### **1 Introduction**

This Corrigendum 1 to Circular Letter [6/LCCE/105](#) of 3 June 2020 is to inform that due to the continued exceptional circumstances and global concern caused by the Coronavirus ([COVID-19](#)), the meetings of Working Parties 6A, 6B and 6C will be convened fully electronically (virtual meeting / remote participation only) on the planned dates 5 to 15 October 2020 (see table below). Please note that the meeting of Study Group 6 will also be convened fully electronically (see Corrigendum 1 to Administrative Circular [CACE/949](#)).

### **2 Main issues addressed and Programme of the meeting**

The decision to convene the meetings fully electronically was taken in consultation with the management team of Study Group 6, which also agreed that the meetings of Working Parties 6A, 6B and 6C should give priority to:

- 1 Work associated with WRC-23 agenda items in support of other ITU-R responsible groups to which these agenda items have been assigned (see Document [6/1](#) and [CA/251](#));
- 2 Liaison statements from other groups and external organizations, in particular, but not limited to those performing sharing and compatibility studies and protection criteria associated with the WRC-23 agenda items;
- 3 Topics expected to go to SG 6 (Annex 2 to CACE/949 lists some topics to which draft Recommendations may be developed);
- 4 Other work items, which would require urgent attention and that cannot be postponed to future meetings of Working Parties 6A, 6B and 6C.

Draft agendas of the meetings of Working Parties 6A, 6B and 6C are already contained in 6/LCCE/105, issued on 3 June 2020.

The working hours of the meeting are scheduled to be **1200 to 1600 hours Geneva time (1000 to 1400 hours UTC)**. In view of the circumstances, the above-mentioned working hours will be applicable – on an exceptional basis – to Friday’s session. These working hours were chosen to accommodate the participation of delegates from various time zones. Other relevant information will be published on the Study Group website, as well as in administrative and information documents.

### **3 Contributions**

Contributions are invited to the work of Working Parties 6A, 6B and 6C, particularly noting the four items mentioned in Section 2 above. These will be processed in accordance with the indications provided in Section 3 of Circular Letter 6/LCCE/105. **The deadlines for reception of contributions for these meetings are specified in the table in Section 1 above.**

### **4 Registration and participation**

Registration to these events is mandatory and will be carried out in accordance with Section 6 of Circular Letter 6/LCCE/105. Since the meeting is proposed to be convened as a virtual meeting there is no need to contact the Bureau to request remote participation.

Delegates must register for each WP 6A, 6B and 6C separately and will receive an according link, with no cut-off date for registration.

Test sessions will be scheduled before the virtual meeting to troubleshoot remote participation connectivity issues. It is highly recommended to attend these test sessions particularly for those delegates who intend to actively participate in the discussions. Instructions on the test sessions and how to connect to the virtual meetings will be sent by e-mail to registered participants before the meetings.
