## مذكرة من الأمانة التنفيذية للقمة العالمية لمجتمع المعلومات

### اعتماد المنظمات غير الحكومية وكيانات المجتمع المدني وقطاع الأعمال في القمة العالمية لمجتمع المعلومات

1. تشجع الجمعية العامة للأمم المتحدة في قرارها A/RES/56/183 المساهمات الفعالة والمشاركة النشطة من جميع هيئات الأمم المتحدة ذات الصلة ولا سيما فرقة العمل المعنية بتكنولوجيا المعلومات والاتصالات، وتشجع المنظمات الدولية الحكومية الأخرى، بما فيها المؤسسات الدولية والإقليمية، والمنظمات غير الحكومية والمجتمع المدني والقطاع الخاص، على الإسهام والمشاركة بنشاط في العملية التحضيرية الدولية الحكومية لمؤتمر القمة وفي مؤتمر القمة ذاته.
2. ووفقاً لترتيبات اعتماد المشاركين يتعين تقديم طلبات الاعتماد بالبريد أو الفاكس إلى الأمانة التنفيذية. والموعد النهائي لتقديم طلبات الاعتماد هو ستة أسابيع قبل بداية كل اجتماع من اجتماعات اللجنة التحضيرية. ويطلب من الأمانة التنفيذية أن تقوم، بمساعدة دائرة الاتصال بالمنظمات غير الحكومية في الأمم المتحدة، باستعراض مدى صلة عمل المنظمات مقدمة الطلب بأعمال القمة على أساس خلفيتها وتعاملها مع قضايا مجتمع المعلومات، وبعد ذلك تقديم توصيات إلى اللجنة التحضيرية لتبت في مسألة اعتماد هذه المنظمات غير الحكومية وكيانات المجتمع المدني وقطاع الأعمال التي تعتبر مؤهلة والتي تتصل أنشطتها بأعمال القمة. ويتعين على الأمانة التنفيذية أن تعمم قائمة الكيانات التي يوصى باعتمادها على الدول الأعضاء قبل بدء كل اجتماع من اجتماعات اللجنة التحضيرية بأسبوعين.
3. وقد تلقت الأمانة التنفيذية الطلبات المستكملة الواردة حتى 1 أغسطس 2003 وقامت بتقييمها. ويتضمن الملحق 1 بهذه الوثيقة قائمة المنظمات غير الحكومية وكيانات المجتمع المدني ويتضمن الملحق 2 قائمة كيانات قطاع الأعمال التي أوصت الأمانة التنفيذية بقبول اعتمادها في الاجتماع الثالث للجنة التحضيرية.
4. وتنص ترتيبات اعتماد المشاركين كذلك على أنه يجب على المنظمات غير الحكومية التي تتمتع حالياً بمركز استشاري لدى المجلس الاقتصادي والاجتماعي والتي ترغب في حضور اجتماعات اللجنة التحضيرية والقمة أن تبلغ الأمانة التنفيذية بذلك وأن تسجل نفسها للمشاركة. والقاعدة العامة هي اعتبار هذه المنظمات معتمدة. ومن المقرر أن توزع قائمة هذه المنظمات غير الحكومية على الدول الأعضاء قبل دورة اللجنة التحضيرية بأسبوعين. ولذلك يتضمن الملحق 3 قائمة بهذه المنظمات غير الحكومية التي تتمتع حالياً بمركز استشاري لدى المجلس الاقتصادي والاجتماعي والتي أعربت عن رغبتها اعتباراً من 5 يناير 2003 في المشاركة في اجتماعات اللجنة التحضيرية والقمة.
