he Radio Regulations Board (RRB) is a specific body within the Radiocommunication Sector of the International Telecommunication Union (ITU), which is dedicated to the resolution of conflicts that may occur while implementing the provisions of the Radio Regulations. As such, it has been working together with the ITU Member States and the Radiocommunication Bureau to carry out its mission and objectives.

It plays a key role in the adaptation of the international regulation to the new regulatory paradigms arising from the rapid evolution of the satellite industry and offers timely and effective responses to these issues, which cannot afford to wait for a World Radio Conference (WRC) to be dealt with.

Mr. Henri believes that the RRB is a unique and indispensable ITU body, where developing and developed countries can submit their concerns regarding the implementation of the provisions of the Radio Regulations.

Thanks to his experience of 30 years in the telecommunication sector and in particular to the 14 years spent as Chief of the Space Services Department of the Radiocommunication Bureau, he wishes to make his expertise available to the ITU, the RRB and the Member States, covering technical, regulatory, managerial, policy and diplomatic aspects alike, in order to provide them with suitable responses. Mr. Henri has held various high-level management positions in both the public and private sectors as well as in intergovernmental organizations including the Radiocommunication Bureau.

Throughout his professional career, Mr. Yvon Henri has always strived to initiate, develop and promote policies to enhance the opportunities afforded by the telecommunication/ICT sector, in particular for the global harmonization of space and terrestrial applications, with particular focus on the adaptation of space services to the constantly evolving world.

He has also been actively involved in the definition, development and implementation of numerous national, regional and international satellite network programmes, dealing with governments and industry at political and senior level in both developed and developing countries.

He has been constantly committed to durably strengthen countries' space capabilities over the five continents and has been assisting them with the application of the ITU regulations and with the preservation of their satellite communication rights.

He has been able to acquire a thorough knowledge of space regulations and a comprehensive understanding of the functioning of the RRB thanks to his many years of experience working for the Radiocommunication Bureau.

30 YEARS OF EXPERIENCE IN THE ICT SECTOR

1995-2017 > ITU Radiocommunication Bureau

Mr. Henri has been successively engineer, then Head of the Space Systems Coordination Division (SSC) between 1995 and 2003, before he became Chief of the Space Services Department (SSD) between 2003 and 2017. In this capacity, he was responsible for the international registration, recognition and protection of frequency assignments to all satellite systems and networks, whether commercial, governmental or scientific. As SSD Chief, Mr. Yvon Henri has acquired far-reaching knowledge of the needs and challenges faced by all the Member States, in particular underserved communities worldwide, in their efforts to access the radio-frequency spectrum and satellite orbit resources. He has assisted and supported the development of space projects enabling communications in remote areas.

1993-1995 > France Télécom

Mr. Henri developed and actively promoted consensual positions at several ITU World Administrative Radiocommunication Conferences (WARC) and played an active role in reshaping the international regulatory framework for satellite networks as defined by the ITU, working closely with all administrations, the industry, the satellite operators, and regional and international organizations.

1989-1993 > INTELSAT

Mr. Henri has successfully worked to enhance and improve the organization's status with the ITU, and also succeeded at WARC-92 in gaining additional Ku-band spectrum (13.75-14 GHz).

1981-1989 > Direction Générale des Télécommunications (DGT) then France Télécom

Mr. Henri has been successively network engineer, then engineer in charge of preparations for ITU space conferences.

1979-1981 > Ministry of Foreign Affairs (Libreville, Gabon)

In charge of the technical cooperation aspects at both the Ecole Nationale Supérieure d'Ingénieurs de Libreville (ENSIL) and the Omar Bongo Technical High School, Mr. Henri's first position for the Ministry of Foreign Affairs destined him to an internationally oriented career.
