 - Forum on Artificial Intelligence and Internet of Things in the development of Smart Sustainable Cities to be held on 11 April 2018 (morning)
 - ITU-T Study Group 20 Regional Group for Africa (SG20RG-AFR) to be held on 11 April 2018 (afternoon)
 - Training on e-Waste Statistics to be held on 12 April 2018
- The Green Standards Week acts as a global platform for discussion and knowledge-sharing in order to raise awareness of the importance of and opportunities for using information and communication technologies (ICTs) to protect the environment, unlock the potential of circular economy and expedite the transition to smart sustainable cities.
- 4 The Green Standards Week brings together leading specialists in the field, from top policy-makers to engineers, designers, smart city planners, government officials, regulators, standards experts, academia and others.

- 5 Discussions will be held in English, French and Arabic.
- Participation in the Symposium, fora and trainings is open to ITU Member States, Sector Members, Associates and Academic Institutions and to anyone who wishes to contribute to the work. This includes individuals who are also members of international, regional and national organizations. Participation in these events is free of charge.
- The ITU-T SG5RG-AFR, SG5RG-ARB and SG20RG-AFR meetings will be restricted to delegates and representatives from Member States, Sector Members and Associates of ITU-T Study Group 5 and ITU-T Study Group 20 in the African and Arab regions respectively, in conformity with clause 2.3.3 of WTSA Resolution 1 (Rev. Hammamet, 2016).
