VISION STATEMENT

ICTs to improve the standard of living for all

I present my candidacy as Deputy Secretary General of the ITU. I dedicate my candidacy to ensuring that digital telecommunication/ICTs will improve the standard of living for all. I am committed to ensure ITU pays special attention to least developing countries (LDCs), small island developing states (SIDS), landlocked developing countries (LLDCs) and countries with economy in transition. With the ongoing challenges of climate change, poverty and the pandemic crippling our world, universal access to secure, affordable and trustful ICTs is key to addressing these challenges in order to build back better and improve the standards of living for all. I am committed to ensure the ITU remains relevant and contributes effectively to our global effort to build a sustainable world; to ensure resilient communities, cities and economies and to connect the unconnected. To achieve this vision, we need improved coordination among the three sectors and continuous dialogue with the members. Supporting the LDCs, SIDS, LLDCs and countries with economies in transition with advancing ICT infrastructure to the rural areas; and empowering vulnerable populations is critical to leaving no one behind and helping ITU members achieve the Sustainable Development Goals (SDGs).

BIOGRAPHY

A national of the Independent State of Samoa who is highly experienced in telecommunications/information and communication (ICT) development issues in a multicultural setting, Gisa has over 35 years in the ICT sector. She has excellent leadership skills, which is maintained with honesty, courage, strategic thinking and a peoples' person attitude with respect for culture of any country.

Her vision and leadership achieved the telecommunication sector reform of Samoa, which she led, represented Samoa at international conferences and worked at the ITU for 7 years as Project Coordinator and Head of Division for LDCs, SIDS, LLDCs and countries with economies in transition; emergency telecommunication; e-Waste and Climate Change Adaptation. After working for the ITU, Gisa was appointed Director of ICT Development at the Commonwealth Telecommunication Organisation (CTO), and within two months she was also appointed as Acting Secretary General (SG) for over two years.

As SG, Gisa spearheaded the reform of some programmes of the CTO that benefited the Membership, develop innovative ways of delivering services, increasing the Membership, managed the implementation of the CTO Strategic Plan and the operations of the CTO Secretariat, in particular with a view to increasing the transparency and efficiency of the organization among others.

One of Gisa's main contribution was during the time of Covid-19 where her excellent leadership skills moved the CTO to working from home before Government announcement of the lockdown to ensure the safety of staff. In particular, she developed strategies to ensure the Secretariat still functioned efficiently while working from home. Her vision and accurate assessment of the impact of Covid-19 to the Secretariat operation and in particular CTO staff resulted in the collective agreement of staff for reducing salaries due to many Members feeling the impact of Covid-19 and economic downturn.. However, the UK Government COVID19 assistance ensured there was no impact on CTO staff salaries.

Gisa's sound experience in ICT development is evident when she received a fellowship from the Director of the UN Internet Governance Forum (IGF) to work in Geneva for 6 months in setting up the first IGF office and planning the first ever Internet Governance Forum in 2006. It is the same year that she put forward the proposal to include SIDS to the ITU programme for LDCs.

She represented the ITU at the UN High Level Panels for the Sustainable Development Goals (2030) in Geneva and New York, among others.

Gisa is married with 4 children and six grandchildren. She is fluent in English and Samoan while speaking basic French.

Achievements

Gisa's notable achievement include but not limited to the following:

- Spearheaded the reform of telecommunication in her country Samoa through developing the
 national ICT policy, technical review of the Telecommunication Act 2005, tender process that
 successfully achieved the liberalization of the mobile market (2003 2005) at a time when
 liberalization of the mobile market was male dominated.
- Reduced the Training Consultant's fees to more than 50% benefitting the Commonwealth Telecommunication Organisation (CTO) Member States that requested training on any subject (2019).
- Successfully convinced the ITU Membership to include small island developing states (SIDS) to the
 ITU programme for least developing countries at the World Telecommunication Development
 Conference (WTDC, 2006) which was approved unanimously by the Membership. Eventually,
 landlocked developed countries and countries with economy in transition was included.
- Successfully represented the ITU at the United Nations (UN) high level meetings on developing the Sustainable Development Goals (SDGs) 2030 in Geneva and New York ensuring ICT Infrastructure formed part of the SDGs.
- Convinced the drafting group of the Declaration at the World Summit of the Information Society (WSIS) preparatory phase to include a paragraph that focus on least developing countries (LDCs), small island developing states (SIDS), landlocked countries (LLDCs) and countries with economies in transition. Gisa drafted paragraph 16 for consideration of the Plenary, which was approved.
- Successfully planned and organized the first Global Conference on Emergency Telecommunication (GET) that was hosted by Kuwait (2016).
- Resource mobilization for the satellite project of the ITU for SIDS
