The Forum will continue in a virtual format during the months of April and May 2023. The theme of the WSIS Forum 2023 is WSIS Action Lines for building back better and accelerating the achievement of the SDGs.

A/70/1) the WSIS Forum is constantly evolving and strengthening the alignment between the WSIS Action Lines and the Sustainable Development Goals. The format, agenda, and thematic focus are the result of an open consultation process with the involvement of all WSIS Stakeholders and will be available on [wsis.org/forum](https://www.itu.int/net4/wsis/forum/2023/HighLevel)

Considering your country's significant efforts in fostering the development of information and knowledge societies, your contribution with a policy statement during the High-Level Policy Sessions would be most welcome.
