I have the honour to inform you that the Consultation by Correspondence, carried out by [Circular Letter No. 24/38](#) of 24 June 2024 relating to the precise place, exact dates and draft Agenda of WTDC-25; Agenda of WRC-27; and the Alternative reassessed project of ITU's headquarters premises has received the agreement of the required majority of the Member States of ITU, in accordance with CV 47 of the ITU Convention.

As a result, Member States of ITU have agreed with the following decisions and resolution:

- [Decision 637](#) on the precise place and exact dates of the World Telecommunication Development Conference (WTDC-25), which provides that the WTDC-25 will take place in Baku, Republic of Azerbaijan, from 17 to 28 November 2025;
- The approval of the draft Agenda of the WTDC-25 as outlined in Annex C of the [Circular Letter No. 24/38](#);
- [Resolution 1422](#) on the Agenda of the World Radiocommunication Conference 2027 (WRC-27) and;
- [Decision 640](#) on the alternative reassessed project for ITU's headquarters premises.
