Jennifer Warren is a seasoned senior executive, having served in government, the private sector, and academia for over 35 years.

She currently serves as Vice President, Global Regulatory Affairs & Public Policy at Lockheed Martin Corporation. In this capacity, she leads the corporation's strategy across the Executive Branch, independent agencies, and intergovernmental bodies, managing a broad business, regulatory, and public policy portfolio. Her work focuses heavily on the International Telecommunication Union (ITU), the Inter-American Telecommunication Commission, and the UN Office of Outer Space Affairs.

Prior to joining the private sector, Ms. Warren held several senior roles at the U.S. Federal Communications Commission from 1991 to 1996, including Assistant Chief in the Wireless Telecommunications Bureau and Senior Legal Advisor in the International Bureau. Her expertise spans domestic and international regulatory frameworks, with a specific focus on the space sector.

For three decades, Ms. Warren has been an active participant in and supporter of the ITU and other international bodies. Her engagement spans from the 1995 World Radiocommunication Conference and the resulting ITU-R Joint Task Group 4-9-11 to the recent Inter-Regional Information Sessions in November 2025. Additionally, Ms. Warren was an early appointed member of the UN Secretary General's Internet Governance Forum (IGF) Multi-Stakeholder Advisory Group, where she represented the business community and participated in global IGF meetings, offering expertise on issues related to cybersecurity, spectrum governance, and telecommunications policy.

Ms. Warren is a trusted advisor to the U.S. government and a leader in industry associations.
