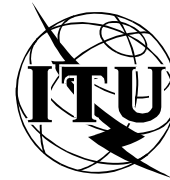

Following a request from the Palestinian Authority and in implementation of RESOLUTION PLEN/3 of the ITU Plenipotentiary Conference (Minneapolis, 1998), the International Call Sign Series **E4A-E4Z**, in accordance with the provisions of No. S19.33 (2086) of the Radio Regulations, has been provisionally allocated to the Palestinian Authority. That provisional allocation is subject to confirmation by the following radiocommunication conference.

Communication of 8.I.1999:

The *Entidad Pública Empresarial Correos y Telégrafos de España*, Madrid, which currently has over 1 400 Bureaufax offices, announces that it intends to open the international facsimile service between public offices (Bureaufax) with any administrations/ROAs that so wish.

It has concluded agreements with nine countries for the exchange of this class of traffic in conformity with the following basic rules:

1. In principle, accounts pertaining to this service will not be settled until such time as the volume of traffic exchanged makes this necessary. Each administration/ROA will retain the amounts charged to their customers ("SKA" (sender keeps all) method).
2. Traffic is transmitted fully automatically via the public switched telephone network (PSTN).
3. This service will be operated in accordance with ITU-T Recommendation F.170.

Remarks by Administrations

Note 1: The Call-Back service is not used in our territory.

Note 2: Despite the Call-Back is prohibited in K.S.A. (Kingdom of Saudi Arabia), this type of traffic is still offering to our customers affecting our revenues. We hope the ITU to take a more clear position to stop routing this traffic to countries that prohibit Call-Back.

Note 3: An Act to amend the Bahamas Telecommunications Corporation Act (15th May 1995) is available at the TSB.

Note 4: The Call-Back practices create an unfair financial disadvantage since more than 70% of our income derives from international calls. Our Administration has not taken any action to prohibit this practice.

Note 5: The Call-Back has a function under pressure.

Note 6: We would like to inform that the Call-Back issue is under consideration by the Regulatory Agency to evaluate the practices and the possible impact on the competitive model adapted to Brazil. We expect to finalize our evaluation until 15th December 1998.

Note 7: No changes are planned to the law in respect of Call-Back or similar methods.

Note 8: The national operator has the monopoly of International telephone services for a five year period.

Note 9: Basic telecommunication services (listed below) in Republic of Croatia shall be conducted exclusively by HPT-Croatian Post and Telecommunications for domestic and international traffic:

- a) transmission of telegraphic correspondence (telegram and telex);
- b) transmission of speech, sounds, data, documents, pictures and other information through the telecommunication capacity in fixed network;
- c) offering of telecommunication cables in lease as pertains to services from items a and b;
- d) linkage of subscribers terminal equipment into public telecommunications as pertains to the services from items a, b, and c;
- e) other telecommunication service as pertains to the services from items, a, b, c, and d, which shall be established by Regulations on Services.

Foreign companies shall conduct telecommunication services exclusively through the HPT (on the basis of bilateral agreement, etc.).

Note 10: In 1996 the Ministry of Communications of Cuba emitted the Resolution 102/96 to establish the illegal character of Call-Back practices in our territory.

Note 11: No specific regulation concerning Call-Back services fall within the scope of the general regulation concerning provision of telecommunications services in Denmark.

Note 12: Since there is no proposed change in legislation as regards Call-Back, there is no move to regulate Call-Back practices here.

Note 13: Call-Back is illegal, all effort should be taken to block and prevent Call-Back as it affects our Telecom revenues.

Note 14: No license is needed to provide value-added services if no connection to the public network has to be made.

Note 15: FCC Public Notice, Report No. IN 96-5. The FCC's International Bureau announced that it intends to sanction international Call-Back providers that configure their equipment fraudulently and in violation of Commission rules to allow foreign customers to place free calls.

Note 16: If more information is needed on the telecommunication legislation in Finland, please contact the Ministry.

Note 17: The Call-Back service operator is required to obtain a licence if the operator establishes or maintain physical equipment in Hong Kong to provide service.

Note 18: The Call-Back operator is permitted to establish and provide Call-Back service in compliance with the terms and conditions of the licence.

Note 19: The Office of the Telecommunications Authority considers that the international telephone service using Call-Back technology is a public telecommunication service. It is, therefore, licensable under the Telecommunications Ordinance in Hong Kong.

Note 20: As the provision of the Call-Back Service is prohibited in Indonesia, therefore the use of such services are strictly illegal.

Note 21: Indonesia has already prohibited Call-Back practices in the country through our Ministerial Decree.

Note 22: Effective August 30th, 1994, the Indonesian Government had stated its policy on the restriction of the implementation of international telecommunication services using Call-Back system in Indonesia, through the enactment of the Minister of Tourism, Posts and Telecommunication Decree No. KM.72/PB.103/MPPT-94. In accordance with the above decree, the government had asked all telecommunication providers to fully support the Indonesian Governments decision and requested that all existing providers of such service in Indonesia to cease their operation, provision and/or promotion of the service as these service is now considered illegal.

Note 23: Call-Back in our country is prohibited and we do not allow it and our plan is to keep this status.

Note 24: The Ministry of Posts and Telecommunication has implemented the following policy-set to regulate the provision of Call-Back in Japan.

1. Objectives of policy-set
 - 1) the implementation of the relevant decision of the ITU such as the Resolution 29 on the alternative calling procedures of the 2nd World Telecommunication Standardization Conference (WTSC-96) (1996, Geneva).
 - 2) the further promotion of competition and benefits of the consumers of the telecommunication services.
2. Composition of policy-set
 - 1) The provision of the methods of Call-Back which seriously degrade the quality and performance of the PSTN, namely, constant calling and answer suppression, has been prohibited. For this purpose, the amendment of the Terms and Conditions of the type I telecommunications carriers have been granted at 24 January 1997 in order to enable them to refuse such usage of their network. The amendment has come into effect on 1 February 1997.
 - 2) At 8 July 1997, the type II telecommunications carriers who are engaged in the provision of Call-Back were:
 - a) notified of the relevant ITU Resolutions and the names of countries where the provision of Call-Back is expressly prohibited;
 - b) notified that the traffic statistics of their service are going to be subject to the periodic report to the Ministry, to help to watch out for traffic trends and implement the relevant Resolutions in an appropriate manner;

- c) notified that the Ministry would take all possible measure to stop Call-Back provider from offering service to the user of the country where the provision of Call-Back is expressly prohibited, once it detects such operation in the future.
- 3) At 8 July 1997, the Ministry published the relevant ITU Resolutions and the list of countries where the provision of Call-Back is expressly prohibited. The list will be kept up-to-date on the MPT Homepage (<http://www.mpt.go.jp>).

3. Future

Once the ITU finds some method of Call-Back (other than constant calling and answer suppression) harmful to the network, the implementation of the safeguard measurement which is necessary and reasonable will be considered consequently.

Note 25: The telecommunication services in Poland can be provided only by the companies granted with the concession from the Minister of Posts and Telecommunications, registered and established in Poland.

Note 26: Call-Back regulation shall be a matter for the legal framework of voice telephony liberalization to be accomplished in 2000 (and not until 2003).

Note 27: The market for international calls will be open on 1 January 2003.

Note 28: Lawfully established companies based in Senegal may be authorized to practice Call-Back in accordance with the regulation in force.

Note 29: The legislation does not require any licence for this kind of service.

Note 30: Call-Back service, regardless being called by any trade or service names, is not in accordance with the relevant telecommunication laws of Thailand. Thus, it is formally prohibited to engage in such practices in Thailand.

Note 31: An administrative measure from the regulation authority forbids Call-Back in a general manner.

Note 32: There are no specific provisions prohibiting Call-Back. However, Call-Back operations have not been challenged by any Canadian telecommunications organization and therefore the regulator, the Canadian Radio-Television and Telecommunications Commission has not been required to make any determination on this matter.

Note 33: GTO is sole provider of telecommunication services in Oman. Anyone practising such business without prior permission of GTO is totally in breach of the national law. Call-Back is therefore considered illegal in Oman.

Note 34: Call-Back operation is not in accordance with our national law. Türk Telekom has taken some measures, within the constraints of Turkish National Law to prohibit the unauthorized activities of the Call-Back marketing companies. Türk Telekom has already announced the prohibition of the Call-Back through the ITU Operational Bulletin.

Note 35: Call-Back service is prohibited although the current legislation does not specifically mention this because this was enacted without having foreseen such services coming onto the scene.
