Botswana Telecommunications Authority (BTA), Gaborone, announces that the number change schedule previously released in December 2001 has been revised.

The public is requested to note that number changes for Ramotswa, Kasane, Mahalapye, Gantsi, Palapye, Selebi-Phikwe, Francistown, Letlhakane/Orapa, Kgalagadi, Serowe, Maun and Kweneng areas have already taken place. The remaining areas of Gaborone, Borolong/Ngwaketse, Mochudi, Lobatse and Jwaneng will be changed as per the revised number change schedule. The dates for the number change for the remaining areas were brought forward to allow for speedy implementation of the number changes. This will allow for the completion of the number change by the 1st quarter 2003, with parallel running going on until July 2003.

Call-Back and alternative calling procedures (Res. 21 Rev. PP-98)

Bosnia and Herzegovina

Communication of 29.VIII.2002:

Prohibition of "Call-Back" in Bosnia and Herzegovina

The *Communications Regulatory Agency (CRA)*, Sarajevo, announces that in accordance with the Resolution 21 (Rev. Minneapolis, 1998) of the ITU Plenipotentiary Conference (Minneapolis, 1998), the Council of Ministers of Bosnia and Herzegovina has issued the Decision on prohibition of alternative dialling procedures for international calls (Call-Back), that is published in "Official Journal of Bosnia and Herzegovina" No. 21 of 16 August 2002.

According to this decision, the "Call-Back" alternative dialling procedures for international calls is forbidden both to and from the territory of Bosnia and Herzegovina until 2006.

The decision entered into force on 24 August 2002.

Belize, Benin, Botswana, Brazil, Brunei Darussalam, Central African Rep., Costa Rica, Côte d'Ivoire, Fiji, Gambia, Ghana, Greece, Haiti, Hungary, Iran (Islamic Republic of), Ireland, Israel, Lesotho, Lithuania, Macao China, The Former Yugoslav Republic of Macedonia, Malawi, Mauritius, Moldova, Nicaragua, Oman, Pakistan, Panama, Papua New Guinea, Peru, Philippines, Samoa, Suriname, Syria, Chad, Tunisia, Tuvalu, Vanuatu, Zambia.

This information is the result of a survey made by ITU-T Study Group 3 in accordance with Resolution 21 (Rev. Minneapolis, 1998) of the Plenipotentiary Conference (Minneapolis, 1998) and Resolution 29 of the World Telecommunication Standardization Assembly, WTSA-2000 (Montreal, 2000).
