One still picture is subsampled without any spacial filtering, and a low resolution picture is produced. This low resolution picture is transmitted using a low resolution motion video CODEC.

Next, another position shifted subsampling is taken place and the produced low resolution picture is transmitted using the same low resolution motion video CODEC that is used for the first subsampled picture.

The second picture can be interframe coded and even H. 261 standard can be applied, using the first picture as a reference frame. The subsampled pictures are received and reconstructed to one original still picture at a receiver.

The received picture can be displayed progressively (the picture quality improves as time goes), if some interpolation scheme is taken place for the first picture and displayed at the receiver.
