1. The World Telecommunication Standardization Assembly (WTSA-04), which was held in Florianópolis, Brazil, from 5 to 14 October 2004, decided to maintain in force the ITU-T Recommendation A.8 "Alternative Approval Process (AAP)".

The AAP applies to Recommendations which do not have policy or regulatory implications, and which therefore do not require formal consultation of Member States (see ITU Convention 246B).
