1. La Asamblea Mundial de Normalización de las Telecomunicaciones (AMNT-2004), que se celebró en Florianópolis (Brasil) del 5 al 14 de octubre de 2004, decidió mantener en vigor la Recomendación UIT-T A.8 "Proceso de aprobación alternativo (AAP, *Alternative Approval Process*)".

El AAP se aplica a las Recomendaciones que no tienen consecuencias en materia de política o reglamentación y que no necesitan, por lo tanto, la consulta formal de los Estados Miembros (véase el número 246B del Convenio de la UIT).
