Dear Sir/Madam,

I am pleased to invite your organization to the ITU annual regional human capacity building workshop for Africa to be held in Abuja, Nigeria, from 27-29 August 2018. The workshop is organized by the ITU Telecommunication Development Bureau in partnership with DiploFoundation and kindly hosted by the Digital Bridge Institute (DBI) of Nigeria.

The main objective of these annual workshops is to provide a platform for countries from the Africa region to share experiences, strengthen their knowledge and raise awareness on matters concerned with the theme selected for the year through a multi-stakeholder approach involving representatives from government, academia, ICT/telecoms regulators and ministries, industry, civil society, NGOs and other organizations. These workshops also provide the opportunity for professionals dealing with capacity building and skills development to interact with those dealing with policies, management, planning and development.

This year's theme of the workshop is **"Strengthening capacities in Internet governance in Africa".** This corresponds to the outcomes of the ITU World Telecommunication Development Conference (WTDC) 2017, where ITU Member States agreed that capacity building of the ITU membership in international Internet governance is one of the priority issues to be addressed by ITU's capacity building programme.

More specifically, the objectives of the workshop are to strengthen capacities of the ITU membership in the field of Internet governance, involving different stakeholders in the delivery of the workshop, and to provide a general overview of key aspects related to international Internet governance discussions.

The workshop will therefore be broad in scope, covering a multitude of Internet governance related aspects, including:

- Internet governance in a changing environment brought by automation and the digital transformation,
- Priorities in capacity development in Internet governance for ICT policy makers, regulators, telecom operators, and academia from the African region, and
- Issues on cybersecurity, privacy and data protection in the digital age as well as aspects of human rights.

This workshop is the second in a series of regional Internet governance capacity development events that ITU is organizing in collaboration with other stakeholders. The experience from these workshops will feed into the further development of ITU's capacity development and training programmes in the field of Internet governance, which are offered under the umbrella of the ITU Academy.

This year's workshop is organized in partnership with DiploFoundation, an internationally recognized lead entity in the field of Internet governance capacity development. Representatives from other global and regional bodies working in the field of Internet governance will actively participate in the workshop.

The meeting will be paperless. Participants are therefore invited to download and print the needed documents before and during the event. Simultaneous interpretation will be provided in English and French during the meeting.
