## CoE Network in Africa



#### DURING THE PERIOD 2015 – 2018

- NUMBER OF ACTIVE CENTRES = 4 out of 6
- Total Number of courses = 30
  - Course online = 4
- Total Number of participants = 415
  - ■International = 68
- ITU organize a course on digital marketing for the CoE to improve international attendance of the courses.

# Annual HCB Regional Workshops



- 2015 "Role of Human Resources in the migration to DTTB and digital economy"
  - > 161 participants from 21 countries and 8 organizations
- 2016 "Ensuring child online safety (COS) in a digital world: building human capacity in COS policy formulation and implementation"
  - > 115 participants from 17 African countries, regional and international organizations, industry and private sectors.
- 2017 Mauritius Developing the ICT ecosystem to harness IoT
  - ➤ 121 Participants from 27 Countries regional and international organizations, industry and private sectors
- 2018 Abuja, Nigeria Strengthening capacities the Internet Governance in Africa

# Training organized with partners/project



- Annual Training in Satellite technologies in partnership with ITSO
  - 2 courses/year one in French and other in English
  - Courses delivered using one of the selected CoEs.
  - 30 participants/year
- African Girls Can Code (AGCC)- 4 year project in partnership with UNWOMEN and African Union Commission (AUC)
  - Fist boot camp on going in Addis Ababa, Ethiopia with about 80 young women for African countries.
  - Funding for the 1<sup>st</sup> year secured from Embassy of Denmark.
- Training of the Judiciaries
  - Being implemented in Kenya in partnership with Communication Authority of Kenya
  - Scaling up to other countries (request received from some countries)
- Cyber Security Training in partnership with ICANN and WATRA 15 17
   October, 2018 Ouagadougou, Burkina Faso
