Subject: 20th Global Symposium for Regulators (GSR) Goes Digital in 2020

Dear Sir/Madam,

Some months ago, you may have received an invitation letter to participate in the 20th Global Symposium for Regulators (GSR-20). We were preparing everything to receive you in person and share with you here in Geneva the trends and the subjects that are important in today's world of regulation. Because of the challenges we are all facing with COVID-19, and after careful consideration, we have decided that GSR-20 will go digital, **with all meetings and sessions held online**, and including new options and features to celebrate 20 editions of GSR. I am excited to share with you the details of these celebrations in the paragraphs below, and attach the revised provisional agenda in annex.

Revised Online Programme

To kick off our celebrations of the 20th edition of GSR, we will hold the Leadership Debate on *"Resilient and secure digital connectivity for all – COVID-19 Recovery and lessons learned for better preparedness and response"* and the launch of *Digital Regulation Handbook and Platform* on **30 June 2020**.

From **5** July to **15** August **2020** (exact dates to be confirmed), a series of Special Regulatory Roundtable discussions will be held online, working with our regional colleagues, regional regulatory associations, and partners, and addressing the following themes:

- Institutional governance and regulatory independence in a digital world
- Spectrum allocation, valuation and temporary measures
- Build back better: post-COVID-19 preparedness and Digital Development Joint Action Plan.

On **31 August**, we will hold the Regional Regulatory Associations meeting and the Private Sector Chief Regulatory Officers' (CRO) meeting at the same time in different virtual rooms. The Heads of Regulators Executive Roundtable (upon invitation only) is scheduled for **1 September**, just before the main sessions of GSR.

The core sessions of GSR will be held from **1 to 3 September 2020 in short sessions over 3 hours each day**, focusing on:

- Fit-for-Purpose institutional frameworks for digital transformation: Demystifying the collaborative regulator in a post-COVID-19 digital ecosystem
- Competition in the digital era: a collaborative and cooperative approach
- Insights from the Last Mile Connectivity Lab
- Spectrum valuation and allocation mechanisms (for new services e.g.5G): post-WRC19 and post-COVID-19
- Digital safety and security: What next in a COVID-19 recovery world?
- Sustainable and inclusive societies: Accessible ICTs to leave no one behind.
