Built around interactive high-level panels on topical and cutting-edge policy and regulatory issues, the Europe-Africa Roundtable provides regulators and policy makers with a unique platform for discussions among peers and other digital stakeholders.

The Roundtable will primarily focus on:

- Exploring regional perspectives on Regulation4digitaltransformation: Accelerating inclusive connectivity, access and use;
- Understanding collaborative regulation for inclusive connectivity with the presentation of case studies;
- Unlocking investment in connectivity through infrastructure sharing, co-deployment and universal service regulation;

• Fostering interregional collaboration between Europe and Africa in the field of regulation.
