ICTA initiated a Project with the Ministry of National Education in order to instruct trainers on safer use of Internet

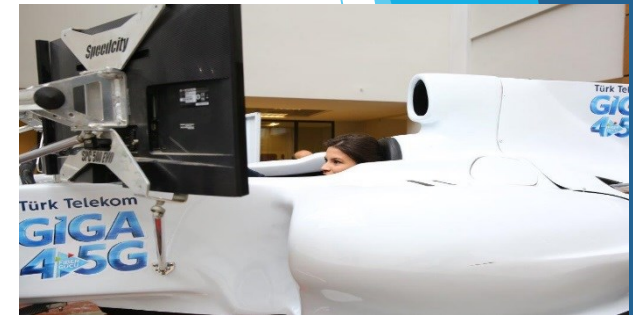
Under this Project, 106.222 teachers participated to seminars during local face-to-face trainings between 2013-2016.

These trainings have been transformed into distance learning modules in 2016. By the end of 2016, 42.077 teachers and school managers participated in distance learning.



Awareness Activities - Safer Internet Day (SID)

- ▶ SID 2017 events were celebrated by ICTA with different activities.
- ▶ Google, Facebook, Twitter, Samsung, Turkish ISPs (Turk Telekom and Turkcell) and different NGOs opened their stand for children.
- ▶ Children carried out many activities related to the effective use of technology and the conscious use of the internet.



Awareness Activities - Safer Internet Day (SID)

- ▶ ICTA also launched a video competition to encourage young people, aged 12-18, to create a one-minute video to display on what they understand about staying safe online. Many videos were sent throughout the contest. The contest winner children got their awards at the event of SID 2017.
