5. What is the ITU Membership approval procedure?

Fill in the Application form [here](#). Our colleagues from the [ITU Membership Department](#) will further request the approval of the Telecommunication Administration in which your entity is based. You will then be informed of the approval of the Administration and receive the invoice. Your Membership will be activated as soon as you pay the invoice.

6. Can I Participate if I am a University?

ITU Academia can participate in the work of the 3 ITU Sectors: [ITU-D](#), [ITU-T](#) and [ITU-R](#).

7. If I become a member, how long is the Membership valid for?

Your Membership will be activated as soon as you pay the pro rata invoice until the end of the year. You will also receive the following year's invoice that is to be paid in the month of March the latest.

By creating your TIES account, you will gain access to restricted documents and contributions produced by our Conferences and meetings.
