Background [max 300 words]

The Communications Authority of Kenya (CA), the ICT Regulator, has in place an extensive Child Online Protection Programme (COP) dubbed "**Be The COP**". The programme seeks to create awareness of the dangers that children may be exposed to online. The Programme further seeks to develop and implement sustainable mechanisms that enable children to have a safer internet experience. In addition, the programme empowers and leverages relevant stakeholders to develop and deploy safeguards for children online. The Authority's COP programme is developed and aligned to the International Telecommunications Union (ITU) recommended best practices.

Following the closure of all learning institutions in Kenya due to COVID-19, there has been a sharp upsurge in consumers' use of technology to access goods, services and even learning materials and platforms. This consequently increased the level of exposure of children and youth to communication services and devices to enable them learn, socialise and play.

The Authority, intends to facilitate the implementation of ITU's technical note *"COVID-19 and its implications for protecting children online"* and also to undertake full implementation of the newly launched COP Guidelines 2020.

Proposal [max 400 words]

Kenya is in the process of developing a National COP strategy facilitated by CA through a multisector approach. This will involve all relevant stakeholders. The outcome of this process will be a clear roadmap whose main objective will be to create a safer internet space for children and youth. CA is waiting for administrative approvals and the creation of a National Taskforce to commence this activity. This process will be executed through a Framework Cooperation Agreement with the ITU.

It is anticipated that the strategy shall be developed over a period of nine (9) months and shall incorporate strategies that promote and strengthen collaboration and active participation of national stakeholders in its development and implementation.

With regards to key challenges and opportunities in terms of funding and partnerships, to date generally all COP activities, initiatives and sponsorships have been self-funded. Given The level of investment required in pursuing the COP agenda and this proposal, Kenya welcomes bilateral support from Partners through financial, technical and in-kind assistance.

The approach adopted in Kenya has always been to work through Partnership. Seeing that Child Online protection requires a multi-sector approach, the Authority has always prioritised this issue and continues to engage partners in planning, co-ordinating and execution of most of the COP programme initiatives.

The transboundary nature of COP such as Cross-border issues pose a big challenge and may require international collaboration.
