DRAFT RECORD OF 1ST MEETING OF PRIDA TECHCOM

Gaborone on 29 May 2019

2. APPROVAL OF THE AGENDA

The agenda proposed by ITU for the first TechCom meeting was approved without amendment as shown in **Annex 1**.

3. ELECTION OF THE BUREAU

ITU Chairs the PRIDA Spectrum TechCom as per the terms of reference. Mr. Jean-Jacques MASSIMA-LANDJI was nominated to Chair the TechCom and two rapporteurs were elected, for one-year mandate. It was agreed that Antony Chigaazira of CRASA, based in Botswana, be rapporteur for the first year. Olivie NAKAMATTE, of Uganda Communication Commission was appointed as Vice rapporteur.

ITU Director for Africa (Mr. Andrew RUGEGE) emphasized the need for a baseline so as to know where we are starting from, the target and roadmap. A baseline study is underway.

4. WORKING METHODS AND CALENDAR OF MEETINGS

The TechCom approved its working methods and calendar of meetings as follows:

- Work will be done through both physical and online meetings.
- Meeting was informed that Terms of Reference were elaborated and approved by ATU, ITU and AUC. Some of the key points in the Terms of Reference are:
 - ITU has signed an agreement and the Committee is mandated to advise ITU on technical aspects during implementation of PRIDA; considering reports on progress;
 - The TechCom is composed of representatives from ATU, ITU, Recs
 - Terms of Reference may be amended or modified as necessary by ITU and to be endorsed;
 - Overseeing and reviewing the technical aspects during the implementation of PRIDA output 1;
 - Periodic consideration of reports on progress by obtaining regular updates from ITU
 Project Team regarding progress and performance;
 - periodic consideration of technical issues, challenges and risks faced by the ITU project team, with a view to giving ITU advice about appropriate solutions, actions and risk mitigations;
 - o overseeing periodic benchmarking and consultations of the developed technical policies, systems, solutions versus best practices;
 - o providing independent professional advice as it considers necessary for success of the project.
 - o overseeing suitability of the technical results produced during the implementation of the project, defend, justify and promote products delivered by the project.
 - o providing input and update on the implementation progress to the periodic reports to be submitted to the PRIDA SteerCom.

- Working Methods approved by TechCom as follows:
 - o The TechCom's mandate is for the duration of the PRIDA Project i.e. the mandate shall lapse at the end of the Project.
 - Physical and Online meetings will be held as necessary.
 - Project Manager will be appointed who will decide on the precise matters to be discussed at each meeting.
 - o The next meeting will be held in September 2019 (tentatively) in Addis Ababa.
 - Another meeting will be held after the WRC-19 and CPM23-1 during the second week of January 2020.

LIST OF ISSUES TO BE CONSIDERED UNDER PRIDA SPECTRUM

PART A

The following elements are the indicative list of elements to be considered under PRIDA Spectrum as elaborated in the **Annex 4 of Action Document for PRIDA**.

Output 1: Predictable spectrum allocation, licensing, management including the treatment of harmful interferences and pricing based on international best practices with a forward-looking approach towards the Internet of Things (IoT) is improved:

- 1. Analysis of the current legislative and regulatory framework and analysis of the usage of spectrum as of today as well as in the foreseeable future;
- Analysis of the fibre deployment for backhaul services;

- 3. Development of guidelines and associated case studies on national spectrum allocation, licensing and pricing;
- 4. Development of associated harmonised roadmaps for the adaptation of the current legislative and regulatory framework;
- 5. Technical assistance for national spectrum agencies to transpose these roadmaps;
- 6. Develop harmonised spectrum Refarming methods;
- 7. Support to the implementation of current HCM4A agreement in sub-Saharan Africa and its extension to North Africa;
- 8. EU HCM Software adaptation to HCM4A (inclusion African Maps and African propagation models- long term;
- 9. Technical assistance for the resolution of existing critical situation short term;
- 10. Policy outreach on concept and business models of IoT;
- 11. Development of Guidelines and associated case studies regarding Type Approval, EMF and EMF for IoT;
- 12. Capacity building in spectrum management.

PART B

The following elements are list of elements to be considered under PRIDA Spectrum as elaborated in the ATU Strategic Plan 2019 – 2022 as it relates to the spectrum sector:

- 1. Optimization of the FM Plans and strategy on the introduction of Digital Sound Terrestrial Broadcasting (DSB).
- 2. Development of a harmonised (model) framework for licensing of satellite services.
- 3. Carry out a study on the satellite orbital resources as well as strategy for optimum acquisition, retention and use of the orbital resources in Africa.
- 4. Development of an African frequency plan based on the SADC model and other regional models.
- 5. Best practice guidelines (collection, collation and publication of best practice information on various key aspects of spectrum management e.g. migration and licensing).
- 6. ATU fellowships to pre-selected countries to enable them participate in key ICT events of ATU, ITU, etc.
- 7. Technical Assistance for Digital Migration.
- 8. Radiocommunications for Disaster Management and Relief.
- 9. Contribute towards the development of an African 5G Strategy (AUC) on spectrum pillar.
- 10. Contribute towards the implementation of Harmonised Calculation Method for Africa (HCM4A) spectrum use coordination project. NB: HCM4A is an AU/ITU project.

The activities above from ATU Strategic Plan will be considered side by side with the proposed PRIDA Projects. In an effort to see the synergies and also to avoid duplication, TechCom advised

ITU to liaise with ATU and the RECs. The liaison is to ensure that the PRIDA resources are utilized to achieve the activities in an optimized manner.

A Matrix will be developed mapping both sets of projects to identify areas of synergies and how best the PRIDA resources can be allocated to achieve the activities in an optimized manner. The Matrix will also consider projects and events from all the sub-regions. All RECs will have to communicate to Chair of PRIDA Spectrum TechCom their planned spectrum activities and events to be held before WRC 19. Outcomes of the CRASA (SADC)/ EACO Joint Preparatory meeting will also be communicated.
