We are also pleased to inform you that ITU will award partial or full fellowships, subject to available funding, to facilitate participation from eligible countries (Least Developed (LDC) or Low Income Developing Countries

(LIC)) in the Americas Region. Applicants requesting fellowships, limited to one person per eligible country, are required to submit their fellowship request form duly signed by their respective Administration together with their registration form no later than 14 October 2017.

The ITU and SUTEL are promoting a regional questionnaire which was sent to the relevant actors in the Americas for the development of a regional assessment to be concluded by the date of the event in Costa Rica, in order to be presented to participants. The effective participation of all to collaborate in this survey will be very much appreciated and of great value to the success of this important event.

This year's edition of the event will include in the last day, discussions on digital inclusion initiatives and projects that are designed to promote the empowerment of women and girls, youth, elderly and indigenous people.

We trust that you or a representative of your organization will attend the event to share your experiences and support the dissemination and implementation of best practices in the Americas region aiming at contributing for the future definition of strategies and implementation of policies, regulations and industry codes of conduct to promote reducing the digital divide and the equal inclusion of these groups of people and in particular, Persons with Disabilities in the Information and Knowledge Society.
