This regional event for the Americas is being organized by the Telecommunication Development Bureau (BDT) of the International Telecommunication Union (ITU) in partnership with the Ministry of Science, Energy & Technology of Jamaica.

Information and Communication Technologies (ICTs) have vital importance in the empowerment of individuals and in the promotion and development of accessibility policies.
