DESCRIPTION OF ACTION: [Provide a brief description up to 500 words]

The IFT's Women Experts that Transform Plan is an effort to promote female leadership through actions that increase the participation and visibility of the Institute's women experts in the telecommunications, broadcasting, and digital ecosystem sectors, as well as in the respective labor fields in which they have specialized. One of the intentions of the Transforming Experts Plan is to make visible the importance of women's work in telecommunications, as well as the need for girls to be increasingly incorporated into STEM careers.

The project also contemplates inter-institutional collaboration actions to promote greater participation of girls and women in activities and professions related to science, technology, engineering, and mathematics careers.

Since its presentation on April 28, 2022, meaningful inputs have been consolidated, such as the Directory of Women Experts, useful for accessing the experience of the Institute's Women Experts. Likewise, a Social Communication strategy has been implemented, and a series of participations in different forums and spaces to publicize the success stories of women who have stood out in the field of telecommunications at the IFT and who have achieved important achievements in their professional careers.

On the other hand, workshops and training courses have been given to raise awareness about the importance of the Gender Perspective and its incorporation into the daily work of the IFT. Finally, contact has been established with the main universities of the country to generate collaborative activities.

The implementation of this Plan has favored the visibility of women expert collaborators of the IFT in public spaces, forums, interviews, and the preparation of video material in which they tell their experiences to encourage other women and girls to achieve their goals of professional development.
