I would like to invite you to participate in the follow-up meeting of the Connect Asia-Pacific Summit and the launch of the ADB/ITU initiative on ICT for Development for the Asia-Pacific region which will be jointly organized by the International Telecommunication Union (ITU) and the Asian Development Bank (ADB), and kindly hosted by the Department of Science and Technology Technology – Information and Communication Technology Office (DOST-ICTO), Government of the Philippines. The meeting will be held at ADB Headquarters in Manila, Philippines from 29 to 30 April 2014.

A number of projects and partnerships were identified as market opportunities by the ITU, relevant partners, and stakeholders at the Connect Asia Pacific Summit which was held in Bangkok, Thailand on 18 November 2013 among them the ADB/ITU initiative on ICT for Development for Asia-Pacific region (ICTD-ASP). The meeting targets **senior officials** of ministries/regulators in charge of ICTs and telecommunications, and **senior management** of private sector organisations, international organisations, NGOs and agencies interested in participating in the meeting.
