The RDF-ASP 2015 will address in detail the five regional initiatives approved by the WTDC-14, providing members with an opportunity to exchange experiences and best practices in the implementation of these initiatives as well as the Connect Asia-Pacific Summit 2013 outcomes. The Forum will also have tracks dedicated to digital financial inclusion, ICT applications, human capacity building, Green ICTs etc.
