✓ A "Self-Check Mobile App"

: to ensure accurate instructions are received and followed by individuals entering Republic of Korea including diplomats, government officials etc.

✓ COVID-19 "Self-Quarantine Safety Protection App"

: to facilitate monitoring of self-quarantine by local governments

✓ The alert messaging service (text messages)





Legal and Institutional Framework for Personal Data

- ✓ Korea has gone through the epidemiological crisis when MERS outbreak in 2015. To respond more systematically for this kind of outbreaks, Korea has revised the Infectious Disease Control and Prevention Act(IDCP Act) which serves as a legal basis for collecting and use of information required for epidemiological investigation.
- ✓ Regarding the management and the use of personal information, the Personal Information Protection Act (PIPA) and the Personal Information Protection Commission (PIPC) serves as a central administrative body with the primary role of the protection and supervision of personal information.
- ✓ PIPC has released a recommendation for privacy protection while responding to infectious diseases. "COVID-19 Personal Information Protection Enhancement Measures" on September 11, 2020.
