Dear Colleagues,

I am pleased to invite you to participate in the 1^{st} ITU CIS Centres of Excellence (CIS CoE) Steering Committee Meeting, organized by the International Telecommunication Union with support of Odessa National Academy of Telecommunications (ONAT) n.a. A.Popov (Ukraine) and Ministry of Information Technology and Communications of the Republic of Moldova. The Meeting will be held on **30 March 2015 in Chisinau, Republic of Moldova**, back to back with the ITU Regional Development Forum for CIS/RCC "Broadband for Sustainable Development" (Chisinau, Republic of Moldova, 31 March – 1 April 2015).

The 1st ITU CIS CoE Steering Committee Meeting is expected to take key strategic decisions aimed at implementation of the approved *Operational Processes and Procedures*. Some of the key issues include approval of candidates to the Steering Committee members for the period of 2015-2018 and election of the 2015 Steering Committee Chair; overview of the CoE New Strategy; the strategic direction of the ITU CIS CoE 2015 onwards and the timetable of annual activities for 2015; principles of ITU CIS CoE financing amongst others.
