ITU Regional Workshop for CIS on the Issues of Organizational and Technical Development of Telecommunications/ICT, Odessa, Ukraine, 23-25 September 2015

On behalf of the International Telecommunication Union (ITU), I am pleased to invite you to participate in the **Regional Workshop for CIS on the Issues of Organizational and Technical Development of Telecommunications/ICT**, which is organized by the International Telecommunication Union (ITU) in cooperation with Odessa National Academy of Telecommunications (ONAT) named after Alexander Popov and will be held in **Odessa, Ukraine, from 23 to 25 September 2015.**

This Workshop is addressed to representatives of ministries, regulators, telecommunication providers, higher and general education institutions, telecommunication equipment manufacturers, medical institutions, and other research and development organizations, telecommunication operators, universities and other stakeholders of the ITU Member States, Sector Members and Associates from the CIS and Georgia.

This Workshop is aimed at sharing practical experience in in the field of organizational and technical development of telecommunications/ICT. In particular, the Workshop will cover the following issues:

- Analysis of current state of the development of telecommunications/ICT in the CIS countries;
- Recommendations of international organizations in the field of organizational and technical development of telecommunications/ICT and best practices of the countries, which reached a high level of ICT development;
- The role of the state in the development of the ICT and legal and regulatory framework of telecommunications/ICT in the CIS countries;
- The issues of organizational regulation of telecommunications/ICT in the CIS countries (including licensing and tariff determination);
- The issues of technical regulation of telecommunications/ICT in the CIS countries (including intercommunication between the networks of different communication providers and shared use of infrastructure);

- Technical, organizational, and procedural aspects of revelation and prevention of cybercrimes, as well as child online protection;
- Organizational and technical issues of human use of telecommunications/ICT;
- Capacity building for telecommunications/ICT development through intensification of the ICT implementation in education.

The draft Agenda of the Workshop is attached herewith (Annex 1).

The Workshop will be conducted in Russian with simultaneous interpretation into English.

The Workshop will be paperless.
