1. Event venue

8. Currency/exchange/credit cards

National currency unit in Kyrgyz Republic is som (KGS). Credit cards are accepted in banks, large hotels, some travel agencies and shops.

As of 27 June 2016, Kyrgyz som exchange rates were as following:

1 RUB = 1.0279 KGS

1 USD = 67.3566 KGS

1 EUR = 74.9578 KGS

8. Communication means

10. Visa support

Entry visa for Kyrgyz Republic is **not required** for citizens of Republic of Azerbaijan, Albania, Republic of Armenia, Republic of Belarus, Georgia, Republic of Kazakhstan, Democratic People's Republic of Korea, Republic of Moldova, Poland, Russian Federation, Republic of Tajikistan, and Ukraine.

Entry visa for Kyrgyz Republic is **also not required** for citizens of following countries possessing diplomatic passports: Hungarian Republic, People's Republic of China, Turkmenistan, Republic of Uzbekistan, if the period of stay in the country is no more than one month.

Entry visa for Kyrgyz Republic is also not required for possessors of diplomatic passports, who are citizens of the UK, the US, Germany, and Switzerland.

Citizens of other countries can enter the territory of Kyrgyz Republic with a valid entry visa issued by diplomatic or consular mission of Kyrgyz Republic.

Voltage power in Kyrgyz Republic is 220V/50Hz. Electrical plugs are two-pin of European type.

As a rule, in September, the average daily temperature at the lake of Issyk Kul is +24°C, the average night temperature is +10°C.
