I am pleased to invite you to the **Regional Workshop on** *Organizational and Technical Aspects of Broadband Development, which is organized by the Telecommunication Development Bureau (BDT) of the ITU* in collaboration with A.S.Popov Odessa National Academy of Telecommunications (ONAT) of the Ministry of Education and Science of Ukraine and will be held in Odessa, Ukraine, from 27 to 29 September 2017.

This Workshop is addressed to representatives of ministries, regulators, telecom operators, universities and general education institutions, telecommunication equipment manufacturers, research and design institutes, software developers and other interested stakeholders of the ITU Member States, Sector Members and Associates.

The Workshop will be conducted in Russian and English with simultaneous interpretation. The event will be paperless.
