On behalf of the International Telecommunication Union (ITU), I am pleased to invite you to Regional Workshop on 'Big Data and Cloud Computing' for the CIS and Asia-Pacific regions, which is organized by the Telecommunication Development Bureau (BDT) of the ITU in collaboration with the Ministry for Development of Information Technologies and Communications of the Republic of Uzbekistan and will be held in Tashkent, Uzbekistan, from 19 to 20 June 2018.

This Workshop provides platform for representatives from ministries, regulators, telecommunication operators, academia, telecommunication equipment manufacturers, research and development institutes, software developers and other relevant stakeholders from ITU Member States, Sector Members and Associates in the CIS and Asia-Pacific regions.
