TITLE: Data protection capacity building program

DESCRIPTION OF ACTION:

Personal data protection is one of the priority areas in Azerbaijan. The country recently has developed new personal data protection law to align with international best practices. Adoption of new law will entail strong need for capacity building in this area. The following support is needed in this area:

- a. The relevant theoretical and practical knowledge on the implementation mechanisms of personal data protection specified in the law;
- b. The ability to use the relevant ICT mechanisms to combat against the unlawful dissemination of the personal data;
- c. The ability to navigate through possible numerous mechanisms in regulating the personal data available on social media platforms;

- d. We are expecting to prepare videos of social importance to raise the awareness on personal data protection. Therefore, it is expected to learn about the materials and perspectives to include into those videos within the trainings;
- e. Learning about the other effective and efficient ways of raising the public awareness based on international best practice;
- f. 100% of the personal data controllers and operators being aware about the responsibilities arising from the law.
