### REPORT BY THE 2017 CHAIRMAN OF THE STEERING COMMITTEE OF THE ITU EUROPE CENTRES OF EXCELLENCE

#### 1. Introduction

ITU Centres of Excellence (CoEs) are institutions offering expertise, resources and capacity-building knowhow in telecommunications and ICTs training/education through face-to-face or distance learning programmes. They have been identified following ITU CoE Strategy and <u>Operational Processes and</u> <u>Procedures</u>. In Europe, five CoEs (see Annex One) constitute the regional network of CoEs providing human capacity building opportunities in particular in field of broadband access, internet governance, cybersecurity, e-waste and conformance and interoperability. The Steering Committee constitutes the main governance structure of the CoEs in the region. Its annual meetings aim at taking key strategic decisions and guidance on implementation of CoE strategy at the regional level. Previous CoE Europe Steering Committee (CoE-EUR-SC) took place on



The following report is prepared as an input to the 4<sup>th</sup> meeting of the Steering Committee and outlines the activities implemented, some challenges encountered in the fourth implementation year of 2015-2018 cycle as well as some observations for consideration of the CoE-EUR-SC meeting.

### 2. Implementation of Activities in 2017

The annual training plan for 2017 was established in consultation with CoEs at the third meeting of the Steering Committee, held on 17 January 2017 (see Annex Two). Out of the total 25 courses planned in the annual training plan for 2017, 18 courses have been implemented, 7 courses have been cancelled.



## Highlights

- I. 25 courses were planned out of which 18 were run (implemented including 2 in progress) and 7 were cancelled
- II. 406 persons followed courses offered by the Europe CoEs with a total of 15210 USD
- III. 4 E-learning courses were run with 257 participants and 7710 USD is expected to be collected by ITU
- IV. 14 Face to Face courses were run with 149 (includes estimates for 2 courses running soon) participants and 7500 USD is expected to be collected by ITU

## **Details on Cancelled courses**

- I. All 7 cancelled courses were face to face
- II. 6 of the cancelled courses were offered at a fee of 500 USD or more per participant
- III. 3 courses of the cancelled courses had a history [cancelled in 2016]
- IV. One CoE did not run any course since the 2 courses it offered were cancelled due to lack of participation.
- V. One CoE run one out of the 3 courses offered since the 2 courses offered were cancelled due to lack of participation.

## 3. ITU Academy Platform Developments

Introduction of new features to the ITU Academy platform since June 2017 I enhanced the value and user friendliness of the platform. Users have been successfully embraced the new features.

- I. Group registration: A focal point of an organization can create an account and register a group of users.
- II. Group payment: A focal point can pay for a group of users either online or offline.
- III. Payment by organization: An individual can register for a course and request its organization to pay for him/her. The user will be asked to indicate the email address of the focal point. An email will be sent to the focal point with detailed instructions of how to pay for the user.
- IV. Users editing offline invoices: An individual user or focal point can edit the details of the invoice before downloading it.
- V. Administrator viewing and editing all invoices: The Administrator can view and edit all invoices generated by users in the ITU Academy.
- VI. Payment through Centres of Excellence: The Administrator can edit the payment settings for a course and indicate users to directly contact and pay to the CoE. If this setting is selected, all users will have to pay through the CoE. ITU is committed to continued optimization of the ITU Academy platform to facilitate coordination with the CoEs and enhance effectiveness for the potential participants.

#### 4. Looking towards 2018

#### **Observations from 2017**

- I. The process of invoicing has been improved by a new function on the platform, which will relieve Finance from issuing invoices manually.
- II. Catalogue 2017 was elaborated and sent to ITU membership. CoE focal points were asked to use the catalogue for promoting all courses. Catalogue 2017 was also provided online from EUR region website.
- III. ITU Office for Europe integrated in all its messaging [e.g. presentations at events] to its membership, information on CoE training opportunities.
- IV. CoEs provided information in some cases with much delay and reports reach ITU after deadlines.
- V. Requests for reducing the fees practised for groups of 3, 5 and more than 10 participants from the same organisation have been received and were turned down by CoEs
- VI. ISQ conducted courses [with a \* in Table 2] targeted to an audience within Government which did not require issuing of ITU invitation letter and promotion on ITU Academy. These courses provided a streamlined way of processing training with a fixed existing set of participants requiring no promotion.

#### Proposals for 2018

- I. Catalogue 2018 draft is submitted for adoption by the CoE Steering Committee and will be finalised for promotion in January 2018. ITU focal point is coordinating this initiative.
- II. It is proposed to that other CoE may consider the targeted audience approach of ISQ.
- III. It is proposed to review the fee of courses above 500 USD that were cancelled. For courses with a history of cancellation, additional actions would be needed, on top of fee review.
- IV. A sustained promotion campaign starting right from January 2018, led by the CoE and monitored closely by the CoE focal point could be envisaged. The promotion would include
  - a course web page hosted at the CoE level with detailed, practical and knowledge focused information that attracts participation
  - this course web page to point to the ITU Academy page and which is referenced with all other [non ITU CoE related courses that the CoE proposes]
  - tweeting by the CoE [and ITU] on the course with "Save the Date for course registration & start info" and "Count down to course registration closing and course starting"
  - CoE to develop a list of events and special interest groups where the course can be promoted and effect focused promotion
- V. Training reports for face to face courses should mandatorily require at least 2 photos [group photo and training in action] so as to provide a more real perspective to the ITU focal point and these elements would be used in future promotional material. Such a practice is currently followed for non CoE training offered in the Europe region.
- VI. Popular courses need to be investigated to understand and replicate positive elements leading to large participation.
- VII. Courses cancelled due to lack of participation to be further investigated at CoE level to understand reason for lack of interest.

- VIII. Courses that have less than 10 participants for 2 years in a row need to be further investigated for revamp or cancelling.
- IX. A strategy of running courses that have already proved themselves in terms of high participation and to revamp or cancel those that have cancellation history or poor participation, would be optimal for Europe.
- X. Courses on emerging topics of interest such a Big Data, Internet of Things, Artificial Intelligence and Digital Innovation may be considered.
