## Subject: "Enabling Environment for 5G" roundtable, followed by 5G Techritory Forum, Riga, Latvia, 27-29 November 2019

I am pleased to invite you to participate in the 5G Techritory Baltic Sea Region 5G Ecosystem Forum, which will be held from 27 to 29 November 2019 in Riga, Latvia.

Within the framework of the ITU European Regional Initiative on Broadband Infrastructure, broadcasting and spectrum management, adopted by the World Telecommunication Development Conference 2017 (WTDC-17), Buenos Aires, the Forum is organized by the Electronic Communication Office of Latvia in close cooperation with the Office of the Prime Minister of the Republic of Latvia, the Nordic Council of Ministers, 5G Automotive Association (5GAA) and the International Telecommunication Union (ITU). As part of side-events to the Forum, ITU and BEREC will co-organize a round table on "Enabling Environment for 5G", to be held on 27th November.

5G Techritory is expected to bring together up to 1000 senior attendees and around 60 senior speakers world-wide including global and regional business leaders, European leading policymakers and government officials, heads of international organizations, investors, business developers, industry experts, content providers, innovation promoters, start-ups, academic and media representatives.
