I am pleased to invite you to participate in the ITU Regional Development Forum for Europe to be organized by the International Telecommunication Union (ITU) at the kind invitation of the Ministry of Economic Development of Italy. The Forum will take place in Rome, Italy, on 6 May 2019 and will be held back to back with the meeting of the CEPT Committee for ITU Policies (Com-ITU), held in the same premises from 7 to 9 May 2019.

Regional Development Forums provide an opportunity for high-level dialogue between the ITU Regional Offices and decision-makers of ITU Member States and Sector Members on the activities carried out at the regional level, so that they can play a part in the implementation of the ITU Strategic Plan, Programmes, Projects and the Regional Initiatives set out in Resolution 17 (Rev.) of the World Telecommunication Development Conference (WTDC-17, Buenos Aires). RDFs serve as a platform for assessing strategic orientations that may have an impact on Regional Offices work plan incorporating regional actions of all three Sectors and the General Secretariat.

In this context, these Forums will report on the implementation of regional activities of ITU carried out in 2018, including implementation of the Regional Initiatives approved by WTDC-17 and related projects. They will provide all stakeholders with an opportunity to discuss 2019 action plans for the respective region, to announce commitments and to exchange experiences and best practices. They will also address Study Groups, Membership, Partnerships, ITU Centres of Excellence, as well as regional contributions to the implementation of WSIS Action Lines and SDGs. The draft agenda of the Forum is attached as Annex 1.

RDFs are open to all stakeholders willing to strengthen cooperation and partnerships among telecommunication/ICT policy-makers, regulators, industry, academia, regional and international development agencies and organizations on specific regional telecommunication and ICT matters.

Please note that the Forum will be paperless.
