# National Broadband Strategy

**Targets 20205** 

- Every HH to have access to 100 mb/ps
- Every entity to have access to 1 gb/ps
- 5G pilots in at least 3 municipalities
- 99% of territory covered by 4G

- 5G Spectrum availability
  - o 700 MHz
  - o 3.4-3.6 MHz & part of 3.6-3.8 MHz

- 5G Spectrum pricing
  - Reserve prices have been calculated for the following bands:
    - o 700 MHz, 800 MHz, 3400-3800 MHz
    - o 1400 MHz, 1800 MHz, 2100 MHz, 2600 MHz,

The communications administrations agree to follow individual national implementation plans, while endeavoring to meet common deadlines set in the EU decisions referenced in Article 2 of the Agreement.

The national implementation plans will take into account the preparatory work already into place in each Eastern Partnership country, relevant technical recommendations and decisions with respect to countries' internationally recognized borders, sovereign interests and rights.

    - o 700 MHz; 800 MHz; 3400-3800 MHz
