What are your *concrete challenges* related to the digital development that might be addressed at the national or/and regional level in 2022 within the framework of the ITU Regional Initiatives for Europe and BDT Thematic Priorities?

Hungary considers the implementation of 5G technology as a concrete challenge at the country level as well as the regional level. In particular, the challenge relates to phasing out 3G technology and implementing full standalone 5G networks as well as creating the necessary technical and financial conditions to ensure its implementation.

Hungary believes that advancing the discussion on these matters is key to ensure that countries in Europe are supported in their efforts towards the implementation of 5G. For this reason Hungary proposes to support the organisation of a regional conference in 2022 to address such items.
