International Telecommunication Union (hereafter: ITU) plays an essential role in fostering standardization and development with operational programmes and as a platform for exchange of knowledge between Member States on the most welcomed practises. Republic of Poland as a Member State of the ITU Council intents on the most active promotion of reviews of ITU's accomplishments, both internally and internationally.

Taking into account changing nature of the digital affairs it is a necessity for public sector to adapt. As representatives of governmental organization we recognize that many European Member States took different approach to follow internationally on digital affairs. Such state of play comes with advantages and disadvantages when it comes to capacity building in following the topics of interests and implementing solutions at national level.

Therefore Republic of Poland encourages ITU Office for Europe and Member States themselves to engage on initiatives that would impact cooperation on capacity building of public sector. As the very goal of ITU is to promote common standardization we wish to share and learn from other Member States to ultimately establish the most efficient model for common European approach to ITU affairs.

Ministry of Digital Affairs has done significant progress in establishing the environment for digital development and to introduce digital means to the citizens with respect to international regulations. With the most recent re-organization we have established Ministry of Digital Affairs that will focus among others on roll-out of broadband infrastructure, broadcasting, cybersecurity and spectrum management but at the same time on IoT and emerging 5G solutions – both regarding the standardization and operational programmes for roll-out of initiatives.





Ministry of Digital Affairs of the Republic of Poland is willing to provide all support to indicatives bringing closer the experts on capacity building that is relevant to digital affairs. As for year 2023 we encourage ITU Offices for Europe on establishing Remote Forum for Europe on Public Sector approach to Digital Affairs. All European States shall make use of opportunity to gather knowledge that will support them to face challenges that are to be addressed in national initiatives roll-outs.

Therefore the Forum shall include:

- National policies and strategies for Digital Affairs New business paradigms;
- Regulatory frameworks fostering standards implementation;
- Roll-out of digital tools in public sector;
- Approach to ITU Affairs and preparation process to World Summits on National level;
- Innovation ecosystems;

The outcomes of the Forum is undoubtedly contribute to the works of Member States, given them relevant feedback on good practices that are implemented in the region. The Forum shall be promoted among Policymakers, Regulators and other institutions that take part in preparation process.

At the same time we are looking forward for further straitening relations on bilateral level with all interested partners.
