TITLE: Media Online - Child Protection in online media

**DESCRIPTION OF ACTION:** [Provide a brief description up to 500 words]

The explosion of information and communication technology has created unprecedented opportunities for children and young people to communicate, connect, share, learn, access information and express their opinions on matters that affect their lives and their communities. But wider and more easily available access to the Internet and mobile technology also poses significant challenges to children's safety – both online and offline.

Albania has made remarkable efforts in recent years to establish the fundamental pillars for the Child Protection System. The core legislative and policy framework around child protection was significantly reinforced in 2017, with the adoption of the new Law on the Rights and Protection of the Child and the Criminal Justice for Children Code, both drafted with UNICEF's extensive.

Recently a new law was approved for some amendments in audio-visual media law covering the video sharing platforms. Child protection in media online platform is part of new regulations asking for development of code of conducts from video-sharing platform providers in order to create a safer online environment for children and young people.

We are interesting on ITU support through a technical assistance on raising awareness and education about safer internet in online media and to support the relevant institutions, entities in drafting the guidelines or code of conduct for child protection in online media.
