





Regional E-Waste Monitor for the Western Balkans Launching Event



Background

E-waste constitutes one of the fastest growing streams of physical waste in today's global environment and a threat to sustainable development. Data and comparable overviews on e-waste are essential in all stages of the policy cycle, to evaluate developments over time, to elaborate national and international policies and to limit e-waste generation, to prevent illegal dumping, to promote recycling, and to create jobs in the recycling sectors. However, only a very limited number of countries collect internationally comparable e-waste statistics and comparable overviews on e-waste management at the regional and national level.

As in the rest of the globe, e-waste is also on the rise in the Western Balkan countries of Albania, Bosnia and Herzegovina, Montenegro, North Macedonia, and Serbia. Technological innovations, brief product lifespans, and an increased purchasing-power due to a growing middle class are among the key drivers for the increase of e-waste in the region. A joint ITU-UNEP-UNITAR project – the Regional E-Waste Monitor for the Western Balkans – started in January 2022 with the aim of collecting internationally comparable e-waste statistics and data in the region. This initiative has resulted in the development of a Regional E-Waste Monitor for the Western Balkans Report, which provides an assessment of statistics, legislation, transboundary movement, and management infrastructure of e-waste in the five project beneficiary countries.

Objectives:

This event marks the final milestone of the project with the launch of the Regional E-Waste Monitor for the Western Balkans Report.

The event aims to:

- 1. Present the regional and national findings of the project.
- 2. Contextualize the findings from the report with interventions from National Focal Points (NFPs) on the e-waste landscape in each project beneficiary country.
- 3. Provide a platform for discussions on the report findings and possible steps forward at both regional and national levels.
- 4. Generate momentum for policy action on e-waste challenges in the Western Balkans region.
