Ohrid is a city in Republic of North Macedonia and it is the largest city on Lake Ohrid with the municipality recording a population of over 5,000 inhabitants. Ohrid is known for once having 365 churches, one for each day of the year, and has been referred to as the "Jerusalem of the Balkans". The city is rich in picturesque houses and monuments, and tourism is predominant. In 1979 and in 1980, respectively, Ohrid and Lake Ohrid were accepted as Cultural and Natural World Heritage Sites by UNESCO. Ohrid is one of only 28 sites that are part of UNESCO's World Heritage that are Cultural as well as Natural sites.

SOCIAL EVENTS

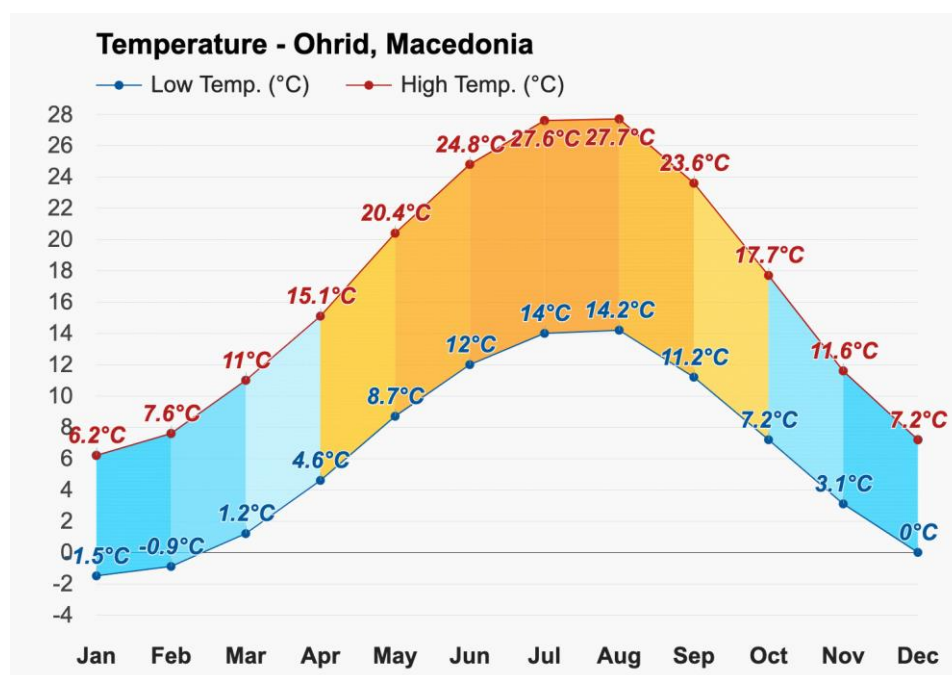
- Welcome Cocktail will be organized on the terrace of the Inex Olgica Hotel & Spa on 13. May 2024 from 20:00- 24:00

Macedonia has a transitional climate from Mediterranean to Continental. In May it varies from 15 to 27 degrees Celsius.



Currency

Currency in Macedonia is Macedonian Denar (MKD). Coins are 1, 2, 5, 10, 50 Denars. Notes are in 10, 50, 100, 500, 1.000 and 2.000 Denars.

All major currencies may be exchanged, but Euros are easiest to exchange.

Exchange rate: March

1Euro=61,5 denars

1GBP=71,93 denars

1USD (\$) = 56,89 denars

(The exchange rates could vary and they should be used as a guideline).

Credit and debit cards are accepted.
