# 7. INFORMATION ON ENTERING THE COUNTRY

# **Migration counter**

Upon arrival in Mexico, the following travel documents must be presented to immigration authorities:

- Valid passport (during stay and upon departure) in conformity with international law. A national identity card is NOT valid for travel to Mexico.
- Multiple Immigration Form (FMM) duly completed (provided by the airline during the flight, or it can be obtained online from the following <u>link</u>).

Immigration authorities may request foreign nationals to state the purpose of their trip and provide the following travel documents: valid passport, visa (if required), any personal information and data requested, reason for travelling, place of permanent residence, address, and length of stay in Mexico, proof of departure, letters of invitation (if required), hotel bookings, financial means, etc.

#### Visa

- Official and diplomatic passports: Delegates holding official or diplomatic passports will not be required to obtain a visa to enter Mexico (90-day permission to stay).
- Regular passports: Requirements to apply for a visa can be obtained from the following <u>link</u>.

<u>Countries and regions NOT requiring a visa to travel to Mexico</u>: Please consult the following <u>link</u>. <u>Countries and regions that DO require a visa to travel to Mexico</u>: Please consult the following <u>link</u>.

These visa requirements may change when you travel to Mexico. Delegates are therefore advised to check current requirements at the nearest Mexican Embassy or Consulate, whose location and business hours can be found at the following <u>link</u>.

Duly registered participants, if so required, may request, through the contact persons previously established, the necessary information to facilitate the visa application procedures to enter Mexico. IMPORTANT: As of April 1, 2022, all Colombian nationals must complete a mandatory preregistration of their trip at the following <u>link</u>.

#### **8. HEALTH REQUIREMENTS**

Mexico has no entry restrictions in the context of the current situation. Nevertheless, entry depends on approval by health and immigration authorities upon arrival, and they may at any time verify if requirements as set forth in applicable legal provisions for immigration have been fulfilled.

#### **IFT Headquarters Building**

To prevent and mitigate the risk of infection by COVID-19 in the workplace, the IFT has implemented various actions to ensure the health of staff and visitors, including the following:

 Voluntary temperature monitoring in turnstiles to people with visible symptoms. If the temperature is higher than 38°, the person will be referred to the medical service, which will determine the actions to be taken.

- Voluntary application of antibacterial gel with alcohol upon admission. Antibacterial gel with alcohol is available on all floors and main entrances.
- Mandatory use of masks inside the IFT facilities.
- Constant cleaning and disinfection of IFT areas and office furniture.
- Integral cleaning and disinfection of the air conditioning system, as well as sanitization of air filters.

Note: Given that the pandemic has not yet reached its end, it is important to consider the unpredictability of its development; therefore, any of the requirements established in this document may be modified to adjust to the different situations that may arise to comply with national and international regulations.

#### 9. GENERAL INFORMATION

#### **Special requirements**

Attendees with accessibility requirements or those who need special services are kindly requested to contact the IFT contact persons and provide a brief description of their needs so that they can receive suitable assistance on time.

#### Weather

Summer (June - September). In Mexico City, the prevailing climate is humid and warm, with temperatures fluctuating between 12°C and 25°C. The weather forecast for August 22 to 26 in Mexico City can be checked at the following <u>link</u>.

#### Time zone

The time zone of Mexico City is Central Daylight Time (CDT), which from April to October shall be 5 hours behind Coordinated Universal Time/Greenwich Mean Time (UTC/GMT -5), as a result of daylight-saving time.

#### Currency

The currency in Mexico is the Mexican peso (MXN). The reference price uses the monthly average exchange rate of 19.7388 Mexican pesos per U.S. dollar\*. Retailers shall not accept any other currency. Delegates are recommended to change their currency for Mexican pesos at foreign currency exchange counters available upon arrival in the airport of Mexico City. Most automated teller machines (ATMs) also take VISA and MasterCard debit and credit cards, among others, for

withdrawal of cash in Mexican pesos. Retailers also accept payment by VISA and MasterCard debit and credit cards.

#### **Health insurance**

If any illness or injury, delegates shall be liable for any expenses incurred when resorting to Mexican medical facilities. They must therefore consider the purchase of travel insurance before leaving for Mexico and ensure they have a suitable level of coverage during their stay in the country.

#### Electricity

In Mexico the electric current is 110 -120 volts (identical to U.S.A. and Canada). Please bear in mind the following recommendations:

- Multi-voltage devices (laptops, etc.): plug adapter.
- Household appliances 220—240V: plug adapter + step-up transformer.
- Japanese household appliances of 100V: step-down transformer from Japan to the United States.

# Tips

In Mexico, at the discretion of the customer, a tip of between 10% and 15% of the total amount billed in restaurants is normally paid as a tip for table service provided.
