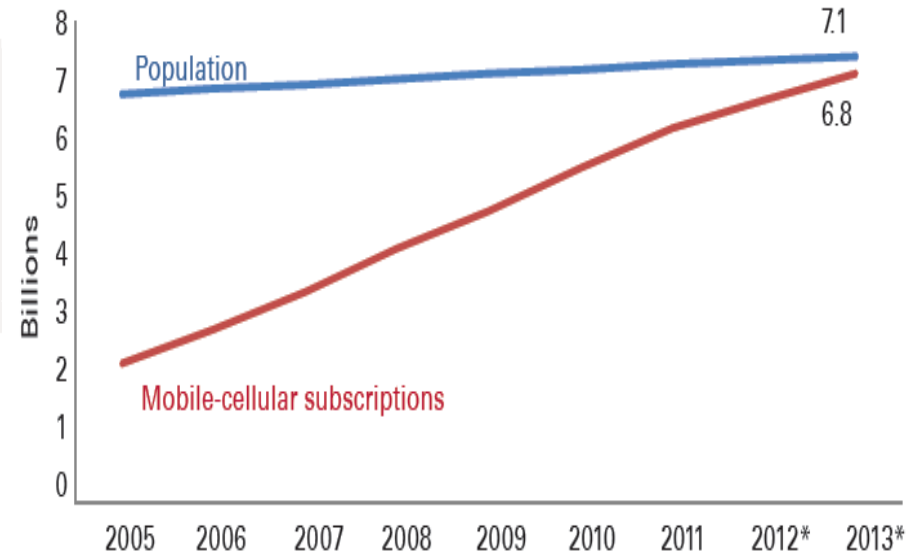
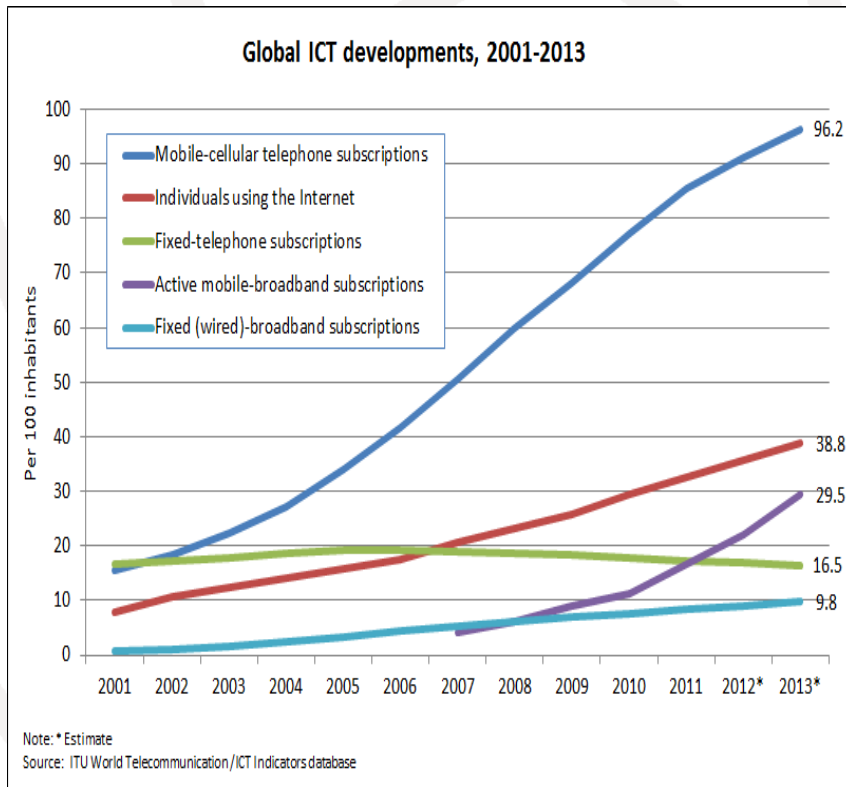

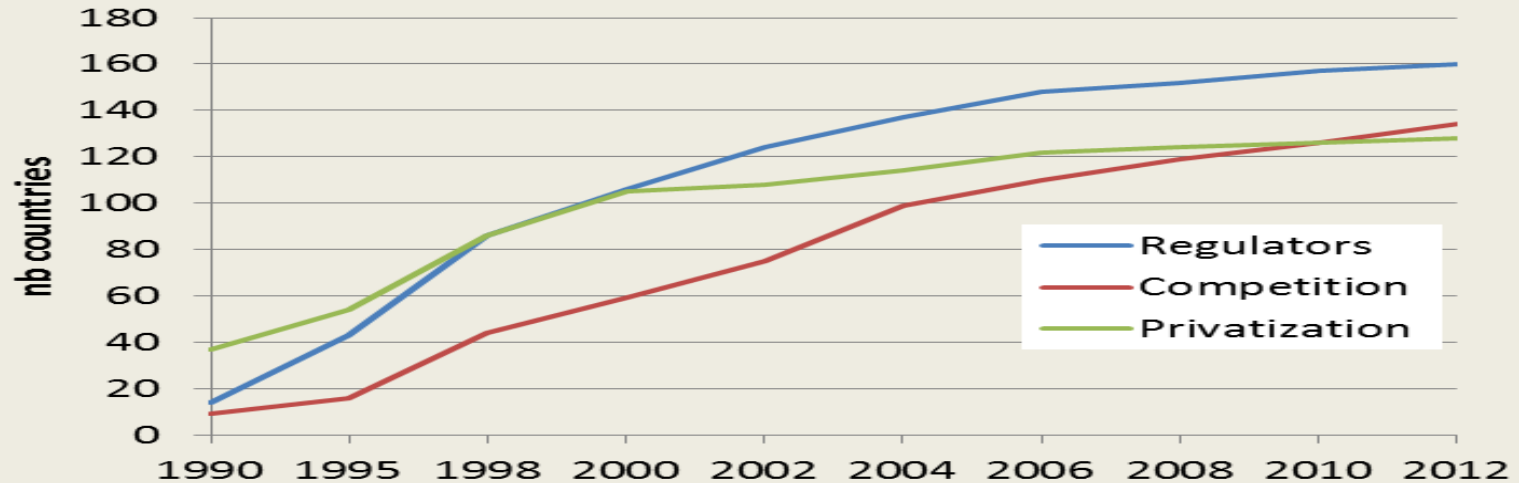

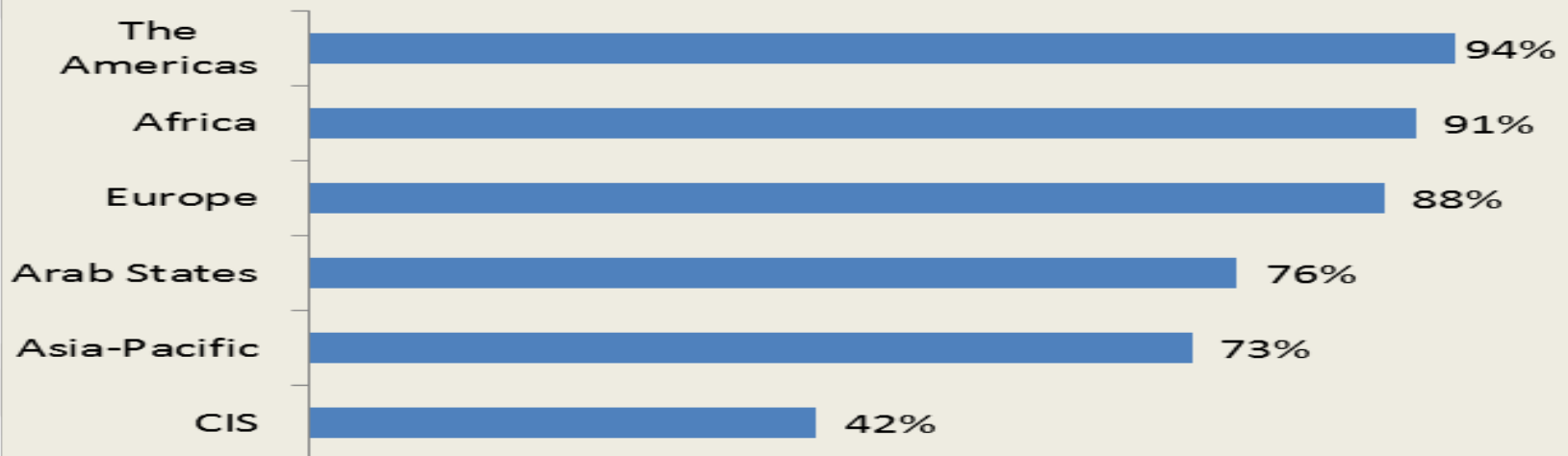

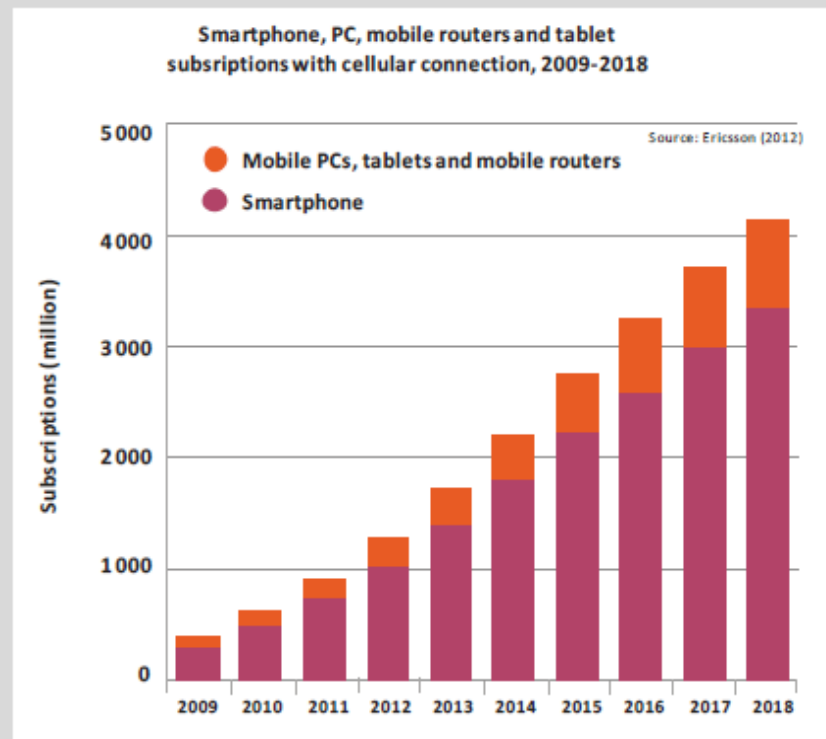
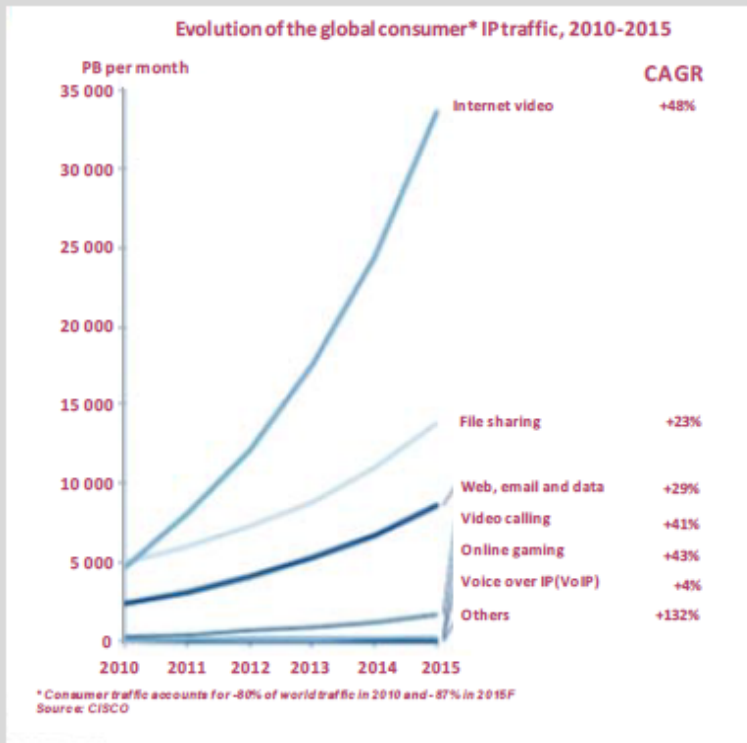


Separate regulators, percentage by region, 2012



Mobile device volumes continue to rise.....

Figure 1.4: Evolution of the global consumer IP traffic, 2010-2015 (left chart) and in mobile device volumes, 2009-2018 (right chart)

Some roaming concerns...

- **The problem of jurisdiction:** International roaming requires a regional or global regulatory approach;
- **Lack of transparency** on IMR charges; frequently change; large price difference between different networks;
- **Lack of awareness** of consumers and businesses (costs of services, substitute and suppliers...)

Challenges of roaming

- Make full use of the great potential of mobile communications;
- Have a coherent regulatory framework and effective competitive regulatory environment ;
- Have retail prices closer to costs of services.

ITU Regulatory, Costing and Tariffs mandate

- Creation of tools for effective regulation and training materials, models and training materials to help regulators and decision-makers, to conduct economic studies/analyses as well as to provide assistance to members
- Organize Platforms at which national policy-makers, regulators, industries and regional regulatory organizations can discuss key issues, share experiences and best practices

The overall aim is to foster equitable and affordable access to innovative and sustainable services

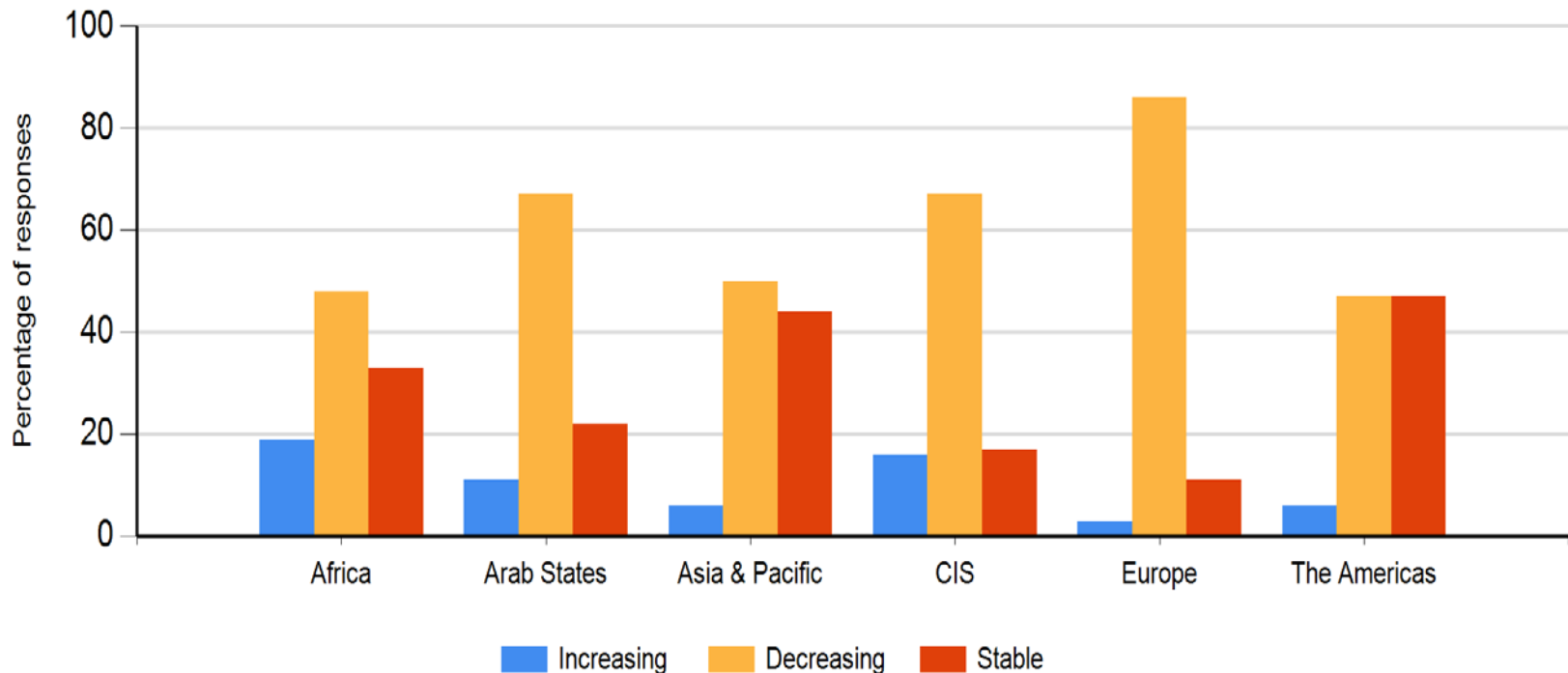
Mobile Roaming (ITR under Articles 4)

- The new provisions on International Mobile Roaming could help provide :
 - transparency of end-user prices for international mobile services
 - satisfactory quality
 - greater cooperation and competition to avoid “bill shock”
 - avoid and mitigate inadvertent roaming charges in border zones.
 - free and quick access for international roaming users to the local number(s) for emergency services

What is the general trend of the IMR retail price of voice over the past three years in your country 2012 ?

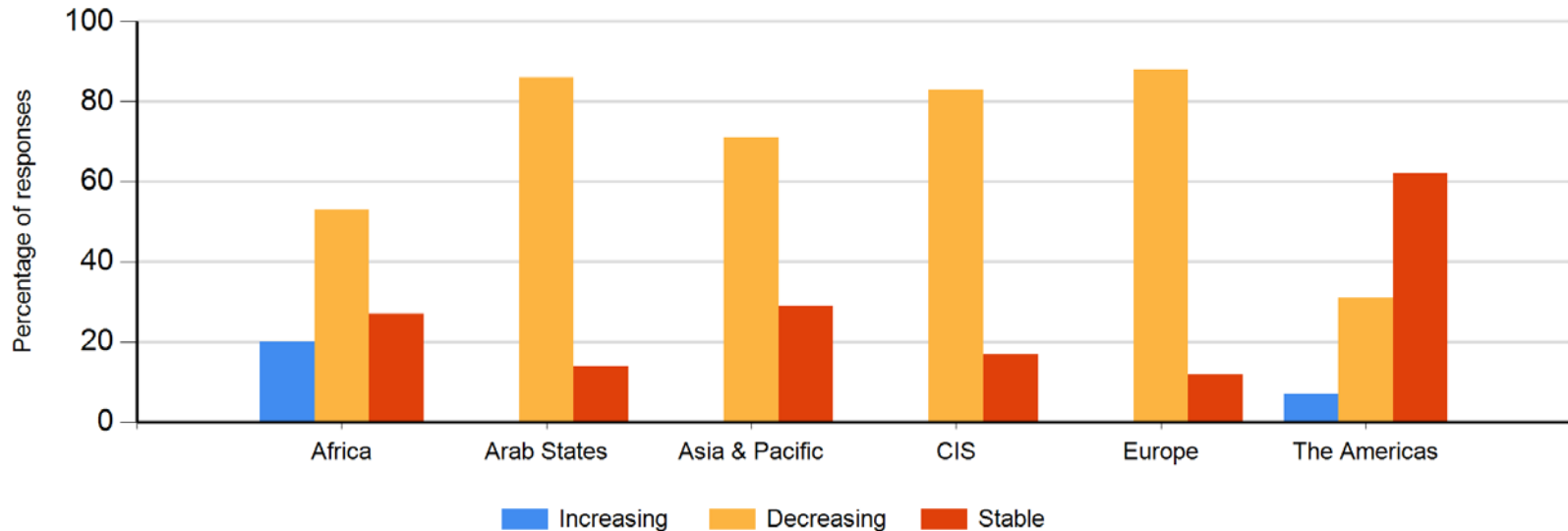
What is the general trend of the IMR RETAIL PRICE OF VOICE over the past three years in your country?, 2012

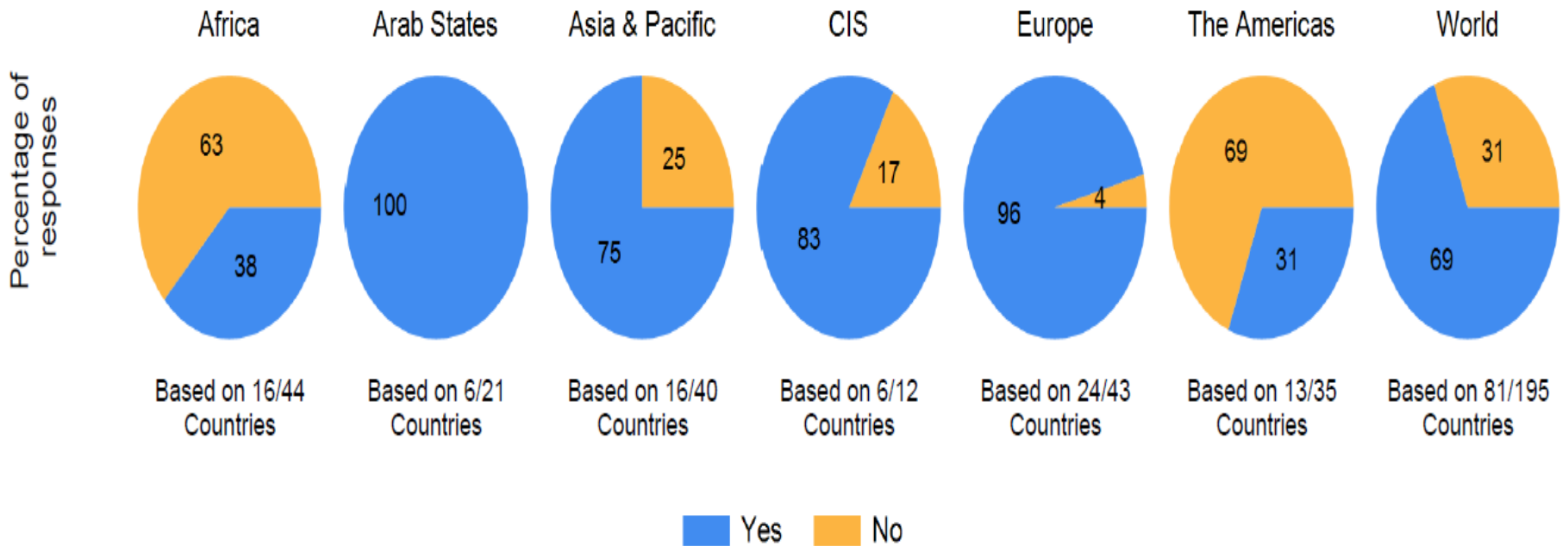
What is the general trend of the IMR Data retail price over the past three years in your country 2012 ?

What is the general trend of the DATA IMR RETAIL PRICE over the past three years in your country?, 2012



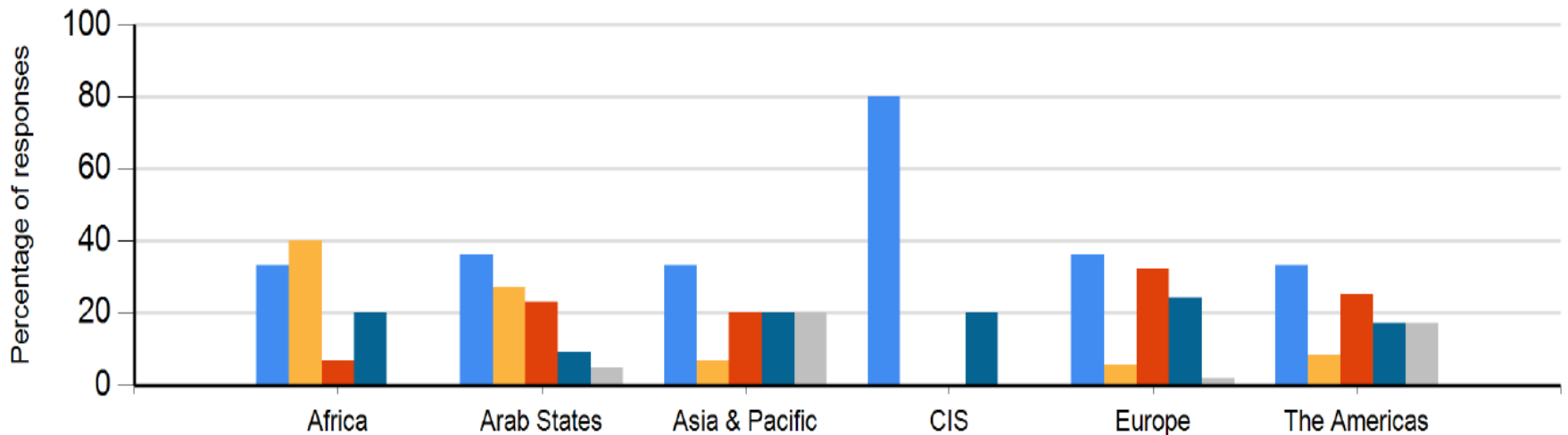

Operators measures to reduce bill shock



- Home operator sends text messages to inform his customers of their roaming tariffs when they arrive in another country
- Mobile operators in the visited country to send SMS with roaming tariffs information to visiting customer (according to roaming agreement between home o...
- Home operator sends alert SMS to the user informing that he/she is reaching the agreed roaming spending limit
- Suspending service when usage exceeds the spending limit fixed
- Other

Some Best practices from recognized by Regulators*

- Empowering consumers to make informed decision through the development of online tools to check speeds, quality of service and price;
- Cooperation and dialogue between all stakeholders;
- Agreement on an interregional regulation;
- Success depends largely on the cooperation of various stakeholders



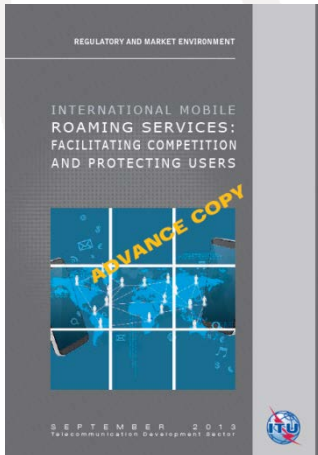
