This version of the Dashboard uses data collected up to December 2023 When a value is not available, NA is reported. In some cases, it is possible that the value reported for disaggregated indicators is for a different period than the main indicator. For most indicators, values are rounded to the nearest integer. As a result, it is possible that the sum of the values of disaggregated indicators does not add up to 100%
