be selected based on their duties and background knowledge of Conformity and Interoperability issues according to the number of positions that are available in the class.

I am also pleased to inform you that **Partial Fellowships** will be awarded based on available funding to facilitate participation from Least Developed Countries (LDC) or Low Income Developing Countries (LIC) to the Training Course. Application for Fellowship, limited to one person per country, must be authorized by the relevant Administration of the ITU Member State. The Fellowship Request Form should be returned to ITU not later than **20 May 2016**.
