#### RESOLUTION 559 (WRC-19)

## Additional temporary regulatory measures following the deletion of part of Annex 7 to Appendix 30 (Rev.WRC-15) by WRC-19

- Objective: Eligible Administrations can apply the Special Procedure contained in Resolution 559 (WRC-19) in order to replace their degraded assignments in the BSS Plans in Regions 1 and 3.
  - The notifying administration shall request subsequent world radiocommunication conferences to consider the inclusion of these assignments in the Appendices 30 and 30A Plans as a replacement of its national assignments appearing in the Plans, pursuant to § 4.1.27 of Article 4 of Appendices 30 and 30A. Under this Resolution, footnotes 10 and 12 associated with § 4.1.27 of Article 4 of Appendices 30 and 30A, respectively, are not applicable.
- Eligible Administrations were identified by the Bureau and published in Circular letter CR/445 of 21 February 2020.
- 45 Administrations have applied the Special Procedure.

#### RRB Decisions in relation to Resolution 559 (WRC-19)

- ✓at its 83<sup>rd</sup> meeting concerning receivability of Res.559 submissions;
- ✓at its 84<sup>th</sup> meeting to protect Reference Situation of Res.559 submissions;
- ✓at its 89<sup>th</sup> and 90<sup>th</sup> meetings concerning examination by the Bureau of Part B of Res.559 submissions.

At every meeting of the Board since 83<sup>rd</sup> meeting, the Board has considered reports of the Bureau concerning the progress of implementation of that Resolution.



#### WP4A actions in relation to Resolution 559 (WRC-19)

- at its October/November 2021 meeting to endorse all the suggestions by the Bureau to further facilitate the implementation of that Resolution;
- at its September 2022 meeting to give technical advice on the compatibility between Res.559 submissions and Regions 1 and 3 Plan assignments.

The Bureau has also periodically submitted to WP4A statistics of coordination activities of Res.559 submissions for its consideration.

- ✓ On 13 December 2022 (14:00 18:00 East African Time) organized by ATU for the 45 Res.559 Administrations (Online workshop).

Adm to submit a request to WRC-23 to replace the current Plan assignments with the corresponding ones in the List	5.2023
