4) Review of findings for assignments of stations in the fixed and mobile services operating in the frequency band 21.4 – 22.0 GHz subject to Resolution 755 [COM5/4] (WRC-12)

Part IIB of this BR IFIC contains 6458 frequency assignments to stations in the fixed and mobile services which are recorded in the Master Register in the band 21.4 – 22.0 GHz in Regions 1 and 3 with favorable regulatory findings. These assignments are subject to confirmation, from the administrations concerned, that they comply with the limit specified in No. **5.530A** (**5.D113**). While waiting for the confirmation, these assignments have been reviewed as follows:

Regulatory finding: favorable finding kept

Date of entry: original date kept Finding observation (13B2): blank Finding reference (13B1): "X/RS755"

It is recalled that Resolution 755 [COM5/4] (WRC-12), WRC-12 decided under *resolves* 1 that frequency assignments of stations in the fixed and mobile services (in the band 21.4 – 22 GHz) recorded in the MIFR or notified under the provisions of Article **11** before 18 February 2012 shall comply with the limit specified in No. **5.530A** (**5.D113**) by 31 December 2015, or the first day of the next world radiocommunication conference, whichever is earlier. In addition, WRC-12 abrogated

Resolution 525 (Rev.WRC-07), which governed the use of this frequency band prior to 18 February 2012.

This review concerns the following Administrations: AUS, AZE, BEL, BUL, E, F, IRN, J, KGZ, KOR, MLA, MTN, OMA, RUS and VTN.

When a notifying administration confirms the conformity of its assignments to the pfd limit of No. **5.530A** (**5.D113**), the reference "X/RS755" will be removed from the findings of the respective assignments. Those assignments, for which no confirmation is received until the date specified in item 1 above, will be reviewed in accordance with Resolution 755 [COM5/4] (WRC-12).
