3) Review of findings for frequency assignments to stations in the aeronautical radionavigation service (ARNS) operating in the frequency band 415 - 495 kHz

Part IIB of this BR IFIC contains 4 frequency assignments to stations in the aeronautical radionavigation service (ARNS) which are recorded in the Master Register in the band 415 - 495 kHz with favorable regulatory findings but outside RR No. 5.77, i.e. having a secondary status. These assignments have been reviewed as follows:

Regulatory finding: favorable finding kept

Date of entry: original date kept

Finding observation (13B2): "S" inserted

This review concerns the following Administrations AFG, BGD and VTN.

Also Part IIB of this BR IFIC contains 19 frequency assignments to stations in the aeronautical radionavigation service (ARNS) which are recorded in the Master Register overlapping the band 405 - 415 kHz with favorable regulatory findings, i.e. operating on non-interference/non-protection basis according to RR No. 5.76. These assignments have been reviewed as follows:

Regulatory finding: favorable finding kept

Date of entry: original date kept

Finding reference (13B1): RR5.76 inserted

Finding observation (13B2): "R" inserted

This review concerns the following Administrations AUS, CHN, MEX and USA.

These reviews are done as the provision No. 5.77 which allocates the frequency band 415 – 495 kHz to the aeronautical radionavigation service (ARNS) on primary basis in the countries listed in this provision was modified in WRC-12.

4) Review of findings for frequency assignments to stations in the aeronautical mobile (AMS) and maritime radionavigation (MRNS) services operating in the frequency band 415 - 495 kHz

Part IIB of this BR IFIC contains 4 frequency assignments to stations in aeronautical mobile (AMS) and maritime radionavigation (MRNS) services which are recorded in the Master Register in the band 415 - 495 kHz with unfavorable regulatory findings, i.e. recorded in non-allocated bands, without Finding Reference. These assignments have been reviewed as follows:

Regulatory finding: unfavorable finding kept
 Date of entry: original date kept
 Finding reference (13B1): RR8.5 inserted
 Finding observation (13B2): "Y" kept

This review concerns the following Administrations BOL, MEX and SUR.

This review is done as the provision No. 5.77 which allocates the frequency band 415 – 495 kHz to the aeronautical radionavigation service (ARNS) on primary basis in the countries listed in this provision was modified in WRC-12.

5) Review of findings for frequency assignments to stations in the aeronautical mobile (AMS) and land mobile (LMS) services operating in the frequency band 510 - 525 kHz

Part IIB of this BR IFIC contains 168 frequency assignments to stations in the aeronautical mobile (AMS) and land mobile (LMS) services which are recorded in the Master Register in the band overlapping 510 - 525 kHz with favorable regulatory findings, i.e. recorded in non-allocated bands. These assignments have been reviewed as follows:

Regulatory finding: unfavorable inserted
 Date of entry: original date kept
 Finding reference (13B1): RR8.5 inserted
 Finding observation (13B2): "Y" inserted

This review concerns the following Administrations ARG, CAN, PNR and USA.

This review is done as the allocation of the frequency band 510 – 525 kHz in Region 2 is changed from the mobile service to the maritime mobile service in WRC-12.

6) Review of findings for frequency assignments to stations in the fixed (FS) and land mobile (LMS) services operating in the frequency bands 161.9625-161.9875 MHz and 162.0125-162.0375 MHz in Region 1

Part IIB of this BR IFIC contains 97 frequency assignments to stations in the fixed (FS) and land mobile (LMS) services which are recorded in the Master Register overlapping the bands 161.9625-161.9875 MHz and 162.0125-162.0375 MHz with favorable regulatory findings, i.e. operating on non-interference/non-protection basis according to No.5.228B. These assignments have been reviewed as follows:

Regulatory finding: favorable kept
 Date of entry: original date kept
 Finding reference (13B1): RR5.228B inserted
 Finding observation (13B2): "R" inserted

This review concerns the following Administrations AUT, AZE, BIH, BLR, CME, D, DNK, ETH, F, I, ISR, ISL, KAZ, KGZ, LBN, LTU, MDA, POR, ROU, RUS, S, SUI, TUR, TZA, UKR and UZB.

This review is done as the Region 1 allocations in the frequency bands 161.9625-161.9875 MHz and 162.0125-162.0375 MHz are modified in WRC-12. Pursuant to the provision No.5.228B, these bands are allocated in Region 1 to the fixed and land mobile services on a primary basis on a non-interference and non-protection basis with respect to the maritime mobile service.

7) Review of findings for frequency assignments to stations in the fixed (FS) and mobile (MS) services operating in the frequency bands 161.9625-161.9875 MHz and 162.0125-162.0375 MHz in Region 2

Part IIB of this BR IFIC contains 65 frequency assignments to stations in the fixed (FS) and mobile (MS) services which are recorded in the Master Register overlapping the bands 161.9625-161.9875 MHz and 162.0125-162.0375 MHz with favorable regulatory findings, i.e. allowed to operate with full rights till 01.01.2025. These assignments have been reviewed as follows:

Regulatory finding: favorable kept
 Date of entry: original date kept
 Finding reference (13B1): Non
 Finding observation (13B2): Non
 Finding action: F/01.01.2025 inserted

This review concerns the following Administrations CAN, CLM, CUB, GTM, MEX, PRG, URG and USA.

This review is done as the Region 2 allocations in the frequency bands 161.9625-161.9875 MHz and 162.0125-162.0375 MHz are modified in WRC-12. Pursuant to the provision No.5.228D, these bands, previously allocated in Region 2 to the fixed (FS) and mobile (MS) services on a primary basis, may continue to be used by these services until 1 January 2025.

8) Review of findings for frequency assignments to stations in the fixed (FS) and mobile (MS) services operating in the frequency bands 161.9625-161.9875 MHz and 162.0125-162.0375 MHz in Region 3

Part IIB of this BR IFIC contains 35 frequency assignments to stations in the fixed (FS) and mobile (MS) services which are recorded in the Master Register overlapping the bands 161.9625-161.9875 MHz and 162.0125-162.0375 MHz with favorable regulatory findings, i.e. recorded in non-allocated bands. These assignments have been reviewed as follows:

Regulatory finding: changed to unfavorable
 Date of entry: original date kept
 Finding reference (13B1): RR8.5 inserted
 Finding observation (13B2): "Y" inserted

This review concerns the following Administrations AUS, CHN, IND, IRN, MLA, NZL, PAK and THA.

This review is done as the Region 3 allocations in the frequency bands 161.9625-161.9875 MHz and 162.0125-162.0375 MHz are modified in WRC-12. Pursuant to the provision No.5.228E, these bands are allocated to the maritime mobile service (MMS) on a primary basis as well as the aeronautical mobile (OR) and mobile-satellite services on a secondary basis.
