3) Review of findings for frequency assignments to stations in the aeronautical radionavigation service operating in the frequency band 830-860 MHz

No. 5.312 of the Radio Regulations (RR) allocates the band 645 - 862 MHz to the aeronautical radionavigation service in a number of countries of Region 1. For Poland this allocation was limited to the band 830 - 860 MHz and existed until 31 December 2012. A review of the MIFR shows that 17 frequency assignments to stations of the aeronautical radionavigation service of the Administration of Poland in this band are recorded in the MIFR.

These assignments were suppressed from the MIFR in accordance with item 3 of Rules of Procedure on No. 11.50.

4) Review of findings for frequency assignments to stations in the fixed service operating in the frequency band 1 559-1 610 MHz

RR No. 5.362B allocates the frequency band 1 559 – 1 610 MHz to the fixed service on a secondary basis until 1 January 2015 in several countries. A review of the MIFR shows that 47 frequency assignments to the stations of the fixed service in the band 1 559 – 1 610 MHz belonging to the administrations of Czech Republic, Germany, Italy, Russian Federation, Slovakia and Slovenia are recorded in the MIFR.

a) Part IIB of this BR IFIC contains 23 frequency assignments to stations of the fixed service in the frequency band 1559 - 1610 MHz under RR No. **5.362B** for which the Administration of Russian Federation requested to continue operation under No. **4.4**. These assignments have been reviewed as follows:

Regulatory finding:	unfavourable inserted
Date of entry into the MIFR:	original date kept
Finding reference:	RR8.5 inserted
Finding observation:	"Y" inserted

b) The 24 frequency assignments to stations of the fixed service in the band 1 559 - 1 610 MHz under RR No. **5.362B**, for which the concerned administrations explicitly requested their deletion, were suppressed from the MIFR.

This review concerns the following Administrations Czech Republic, Germany, Italy, Slovakia and Slovenia.
